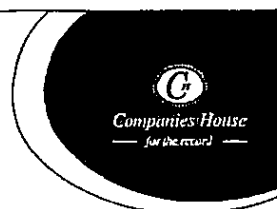

Short particulars

1 By way of fixed charge the following property of the Company owned now or in the future -  
(i) all interests in any heritable freehold and leasehold land (Land) vested in or charged to the Company, all fixtures and fittings attached to that Land and all rents receivable from any lease granted out of that Land,  
(ii) all plant and machinery, including any associated warranties and maintenance contracts,

Note 1 The Debenture contains covenants by the Company that the Company will not without the Bank's consent -  
(a) permit or create any mortgage, standard security, charge or lien on the property,  
(b) dispose of the property of the Company, owned now or in the future, charged by way of fixed charge,  
(c) dispose of the property, other than in the ordinary course of the business, charged by way of floating charge,  
(d) call on, or accept payment of, any uncalled capital,  
(e) deal with its book and other debts, except by collecting them in the ordinary course of its business. In particular, the Company will not realise its book and other debts by means of invoice discounting or factoring arrangements.
