1 Accounting convention

2 Profit and loss account

3 Statement of cash flows

The financial statements do not include a statement of cash flows because the Company, as small reporting entity, is exempt from the requirement to prepare such a statement under Section 7 of FRS 102.

4 Related party transactions

The Company has taken advantage of the exemption within Section 33 of FRS 102 (Related party disclosures) in not disclosing transactions with other wholly owned entities in the Acromas group of companies.

5 Ultimate parent undertaking

The immediate parent undertaking at 31 January 2017 is Saga Group Limited, a company which is registered in England and Wales. The Company is wholly owned by Saga Group Limited.

In respect of the year ending 31 January 2017, Saga plc is the parent company of the smallest group of which the Company is a member and for which group financial statements are prepared.
