

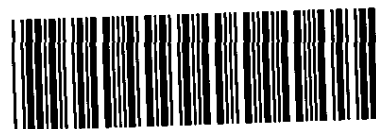



- 1.1 I, Matthew Dunham of Dunham Dean Advisory Limited, Suite 26, Century Building, Brunswick Business Park, Tower Street, Liverpool, L3 4BJ, was appointed as Liquidator of CDO Group Limited (the **Company**) on 11 July 2017. The affairs of the Company are now fully wound-up and this is my final account of the liquidation, which covers the period since my last progress report (the **Period**).

- 5.1 The Directors' Loan Accounts were distributed in specie in October 2017


## **6 Liquidator's Remuneration**
