### **1 Accounting policies**

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

#### ***Basis of preparation***

The financial statements have been prepared in accordance with applicable accounting standards and the Companies Act 1985 and under the historical cost accounting rules.

Under Financial Reporting Standard 1 (revised 1996) the company is exempt from the requirement to prepare a cash flow statement on the grounds that it is a small company.

### **2 Called up share capital**

The company has an authorised, issued and called up share capital of £1.

### **3 Company Name**

The company was incorporated on 11 October 2007 and, on 6 March 2008, changed its name from Mandaco 544 Ltd to TTJJMS Ltd. On 14 March 2008, the company changed its name to 253K Limited.
