## 1 Accounting Policies

## Basis of measurement and preparation of accounts

**DORMANT STATUS** 

The company was dormant (within the meaning of Section 480 of the Companies Act 2006) throughout the year ended 31st March 2016. The company has not traded during the year or during the preceding financial year. During these periods, the company received no income and incurred no expenditure and therefore made neither profit nor loss.

### Other accounting policies

RELATED PARTY TRANSACTIONS

The company was under the control of Mr C M Carey throughout the period. Mr C M Carey is the managing director and majority shareholder.

Mr C M Carey is also a majority shareholder and director in Reed Engineering Building Services Ltd. Included in trade debtors is £6,000 owed from this related party (2015 - £6,000) and in creditors is £5,428 (2015 - £5,428) owed to this related party. Reed Engineering Building Services Ltd is in liquidation.

Other transactions with related parties are disclosed in note 6 - Transactions with the directors.

#### 2 Fixed assets Investments

The company owns 100% of the issued share capital of Reed M&E Ltd. The subsidiary's aggregate capital and reserves at 31st March 2016 was £316,211 (2015 - £123,573). It made a trading profit of £207,042 for the year ended 31st March 2016 (2015 - £120,223).
