This year has again been focused on the Dennis Potter Archive Project and its realisation. This followed our successful joint bid with the Dean Heritage Centre for Heritage Lottery Funding as notified at the end of March 2011. We also attained Local Area Group funding towards the purchase of the archive itself.

The multi-faceted project fits completely with our mission statements and core activities and celebrates the legacy of Dennis Potter, his work and the environment in which he grew up. The main aims of the project are to:

- Secure the Dennis Potter written archive material for preservation, documentation, access and creative enterprise in the Forest of Dean.
- Enable local, national and international access to both written and screen archive with appropriate multi-modal interpretation
- Create a unique selling point for the Dean Heritage Centre as the 'Home of Dennis Potter' to increase visitor numbers
- Provide a focus for teaching, learning, research and public engagement in 'Media, Memory and Community' at the University of Gloucestershire
- Devise, make and screen a community film celebrating and exploring Potter's work as part of the creative culture and heritage of the Forest of Dean involving schools, community members, local organisations and other stakeholders.

2011-12 saw our previous years' work begin to come to fruition. Permission to start the project was delayed until June 2011, whilst copyright issues were resolved and the purchase was made in August 2011. The written archive arrived at the museum in December 2011 and is now held as a part of the centre's collection. An archivist, Phillippa Turner, was employed ready to receive the collection. Her role is paid for as part of the HLF-funded project to work with and train volunteers to document the entire purchased archive.

Potter's films and plays were used as the focus for a GCSE drama group as a starting point for screenwriting, acting, filming and editing their own community film, working with the Rural Media Company The group were able to visit the museum and see part of the archive for themselves. The finished film will feature in the end of project celebrations in 2012-13

The Dean Heritage Museum decided to fully integrate their collection with the story and works of Dennis Potter and Voices Director, Jason Griffiths, began working on producing a new audio trail for the museum. This will link the museum displays with themes in Potters work and is scheduled for launch in autumn 2012. As another part of the DHC's commitment to Dennis Potter, a new exhibition space has been devised.

Lord Melvin Bragg is a patron of Voices in the Forest Community Interest Company and he visited the project in October 2011 to show his continued support and to view the few artefacts sent to the centre as a sample of the archive. Lord Bragg agreed to be involved in the audio recordings for the audio trail being devised and to help with other facets as appropriate.

Additional outputs have come about through the strong partnership working with the Dean Heritage Centre, University of Gloucestershire, Lakers School, Rural Media Company and other stakeholders. The University of Glasgow are now involved partnering the University of Gloucestershire. The University of Gloucestershire acquired additional funding for a PhD student to study the Potter archive and its link to Media, Memory and Community as part of that Research Centre's commitment and involvement in the project. The PhD student started work in March 2012

The official Dennis Potter website has now been taken on by the University of Gloucestershire.

Voices Directors, Ros Daniels and Amanda Smith, also helped evaluate University of Glos Undergraduates' project work on Potter. This was a cross-Faculty assessed module for the students involved.

Another additional outcome is the closer relationship fostered between Lakers School and the Dean Heritage Museum, with pupils being involved in developing other facets of the centre.
