

Building on work in our first year of activity, which highlighted the demand from young people to be more involved in their local heritage and creativity, Voices in the Forest Community Interest Company worked with a range of partners to bring ideas to fruition. Included in our work with young people in the Forest of Dean were two main initiatives.

- Supporting the publication, release, promotion and distribution of a double CD of music by local bands, working with FOIST and Glos Music Forum.
- Working with a group of 13-20 year olds and a host of local individuals and
 organisations on a multi-media project to promote and celebrate the
 creative culture and heritage of the Forest of Dean. This culminated in
 November 2009 with an exhibition and presentation by the young people
 to a large audience and the dissemination of their interactive DVD they
 had devised and produced to all local schools, youth groups, museums
 and other interested parties. Voices were able to support the project
 throughout with information, contacts, resources and skill support. The
 young people involved also earned their Bronze Arts Awards through their
 involvement and dedication to the project.

In summer 2009, the second Forest Literary Festival was held to highlight the wealth of writing talent locally Voices supported the Dean Heritage Centre in their exhibition which included the work of Dennis Potter, Andrew Taylor, Edna

Healey and others in association with the festival, local poets and writers worked with local schools to spread the enthusiasm

A major undertaking has been to develop the Dennis Potter Archive Project Working in partnership with the Dean Heritage Centre, University of Gloucestershire, Lakers School and other stakeholders, Voices of the Forest CIC were the lead applicant to the Heritage Lottery Fund and other fund-holders

The project fits completely with our mission statements and core activities and will celebrate the legacy of Dennis Potter, his work and the environment in which he grew up. The main aims of the project are to:

- Secure the Dennis Potter written archive material for preservation, documentation, access and creative enterprise in the Forest of Dean
- Enable local, national and international access to both written and screen archive with appropriate multi-modal interpretation
- Create a unique selling point for the Dean Heritage Centre as the 'Home of Dennis Potter' to increase visitor numbers
- Provide a focus for teaching, learning, research and public engagement in 'Media, Memory and Community' at the University of Gloucestershire
- Devise, make and screen a community film celebrating and exploring Potter's work as part of the creative culture and heritage of the Forest of Dean involving schools, community members, local organisations and other stakeholders
- Support and involve school pupils and the community in a Forest Summerfest celebrating the local creativity, inspired by the works of Dennis Potter and the Forest of Dean community and environment

In Early March 2010, we received 1st Round approval for our bid for HLF funding and will continue to Round 2 with the support of development funding from the HLF

Our stakeholders are residents and visitors to the Forest of Dean and partner communities with similar objectives. Included in this are service providers, local government and schools. Having completed a large piece of research with young people in 2008/9, we acted upon that research during this year.

The Forest of Dean youth project, Making Our Mark, demonstrated the need for such projects with the core group of young people involved attending over 90 sessions in their own time. This clearly illustrates the commitment and resolve of young people to participate in their local creative culture and heritage. The resource produced is being used in a range of education and youth group contexts and held up as an example of good practice. Consultation following this work has illustrated for more long-term projects of this type.

 During the year, our involvement with the Dennis Potter Archive Project has meant a range of further consultation to demonstrate need for the activities. The fact that a core group of young people worked on MOM for 92 sessions in their own time, illustrated their commitment and This has included work with the University of Gloucestershire's Research Centre for Media, Memory and Community as well as liaison with local schools. The Dean Heritage Centre staff and Trustees have worked with us to get feedback from visitors, volunteers and contacts globally to ensure the viability of the projects in which we are involved. Our success with Round 1 funding from HLF is a testament to the consultancy carried out.
