No members have required the company to obtain an audit of its accounts for the year in question in accordance with section 249b(2).

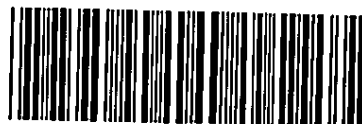
