- 5. An ordinary resolution that the Liquidators remuneration for dealing with the matters arising in the liquidation will be based on a fixed fee of £2,500 plus VAT and authority is given for remuneration to be drawn on this basis.]
- 6. An ordinary resolution that the Liquidators be authorised to draw "Category 2" expenses out of the assets of the Company, as an expense of the liquidation, at the rates prevailing when the cost is incurred, in accordance with the charging policy of Wilkin Chapman LLP, a copy of which is attached to these written resolutions.
- 7. An ordinary resolution that, should the Liquidator deem it appropriate to instruct Wilkin Chapman LLP, then the Liquidator be authorised to instruct and pay fees and expenses to Wilkin Chapman LLP for their assistance in providing legal services to the Liquidator by reference to time properly spent in attending to those legal matters arising in the winding-up, such sums to be approved by members and paid as a category 2 disbursement as an expense of the winding-up, in accordance with the charging policy of Wilkin Chapman LLP, a copy of which is attached to these written resolutions.
