**DIRECTORS**

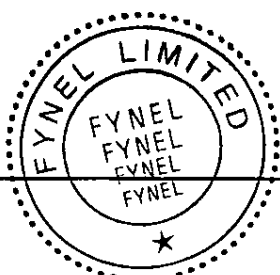
The Directors, being eligible, offers himself for re-election to the board at the next Annual General Meeting of the Company.

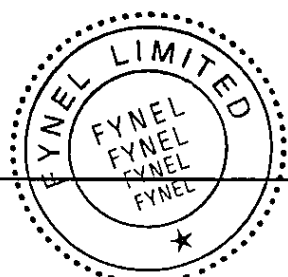

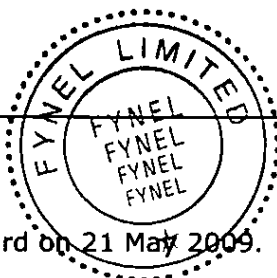
