    - "30 9 Provided that there is an RGIP Director appointed and Hideyuki Hidaka is a Director (or a replacement for Hideyuki Hidaka has been appointed with the consent of RGIP) (such two directors being the "Recruit Directors"), such Recruit Directors shall be able to exercise up to three votes at any meeting of the Directors, provided that the aggregate number of votes that may be cast in respect of any resolution proposed at any meeting of Directors by any and all Recruit Directors (collectively) shall not be more than three "
