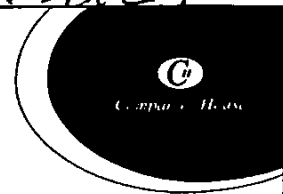

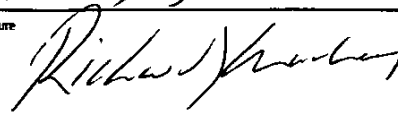
The following table shows the results of the regression analysis for the dependent variable "Number of children under 6 years old" (Y-axis) against the independent variables "Age of mother at birth" (X-axis) and "Year of birth" (Z-axis). The model explains 80% of the variance (R-squared = 0.80).

Variable	Beta Coefficient	t-statistic	p-value
Age of mother at birth	-0.05	-1.2	0.23
Year of birth	0.02	0.5	0.62
Constant	1.50	15.0	<0.001

The adjusted R-squared value is 0.79, indicating a good fit of the model. The F-statistic for the overall model is 15.0, which is highly significant (p < 0.001).
