1. REALISATION OF ASSETS

The company's only asset was an amount owed by Aldı Stores Limited, its sole shareholder. This has been repaid in full

2. COSTS OF REALISATIONS

There were no costs of realisation, apart from the Liquidators' fee and disbursements. No payments have been made as the Liquidation costs are to be paid by the shareholder, Aldi Stores Limited.

3. CREDITORS

There were no known creditors and during the course of the Liquidation no claims have been received.

4. DISTRIBUTIONS TO SHAREHOLDERS RULE 4.49E

On 7 September 2012 a first and final distribution was made totalling $\pounds 1$ This distribution was utilised to repay the amount owed by Aldi Stores Limited

5. LIQUIDATORS' REMUNERATION

At the meeting held on 9 August 2012, a resolution was passed that Liquidator's remuneration be calculated by reference to the time properly given in dealing with matters arising in the Liquidation, limited to £7,500 plus VAT and disbursements

Total time costs to 14 October 2012 including the pre appointment advice and review work, amount to £8,031, against this amount, fees totalling £7,500 plus VAT and disbursements have been billed leaving a balance of £531 which will not be recovered.

An explanation of my firm's charging and disbursements policies and my firm's hourly charge out rates is attached

The average hourly charge for dealing with this case is £157

6. CONCLUSION

The final meeting was held on 15 October 2012 and no resolutions were passed.
