In accordance with the provisions of Section 94 of the Insolvency Act 1986, I present, for your information, my final progress report on the liquidation for the period 17 December 2015 to 9 December 2016

This report should be read in conjunction with my annual progress report dated 6 January 2016

Statutory Information

I, Malcolm Cohen, of BDO LLP, 55 Baker Street, London, W1U 7EU was appointed as Liquidator of the Companies on 17 December 2014

The Companies' registered numbers and former names are detailed in the attached Schedule A They do not have any other trading styles

Prior to liquidation, the Companies' trading address and registered office was 15 Grosvenor Street, London, W1K 4QZ. The registered office was changed to 55 Baker Street, London, W1U 7EU following my appointment.

Receipts and Payments

There have been no receipts or payments in the liquidation period.

The Companies' sole assets are intercompany debtor balance owed by group companies as detailed in the attached Schedule B. These amounts were distributed in specie to the Companies' respective shareholders prior to the final meetings of members being held.

BDO LLP, a UK limited liability partnership registered in England and Wales under number OC305127, is a member of BDO International Limited, a UK company limited by guarantee, and forms part of the international BDO network of independent member firms. A list of members' names is open to inspection at our registered office, 55 Baker Street, London W1U 7EU BDO LLP is authorised and regulated by the Financial Conduct Authority to conduct investment business







HM Revenue & Customs ("HMRC")

I am required to obtain clearances that there are no outstanding matters and no objections to the closure of the liquidations from both the Corporation Tax Inspector, and HMRC's Enforcement & Insolvency Service which provides VAT and PAYE clearances and issues HMRC's proof of debt for all taxes

Corporation Tax

As previously reported I received clearances for Capco Empress State LP Limited, Changeopen Residents Management Limited and Sanderling Enterprises Limited in 2015.

A & P Bolding Limited, Capco CG 2010 Limited and Martineau Properties Limited were all required to submit corporation tax returns for the period to the date of liquidation. These were submitted to HMRC in December 2015.

Further to this I received notification of claims in respect of both A & P Bolding Limited and Capco CG 2010 Limited together with penalty notices. The liabilities were settled by the Companies' parent group in January 2016, and the penalties were successfully challenged

In April 2016 I was advised that both the above two Companies still had residual debts outstanding in respect of interest that had accrued. These amounts were also settled by the parent group

I have now received all corporation tax clearances required.

<u>VAT</u>

Sanderling Enterprises Limited and Capco CG 2010 Limited were registered for VAT but application was made to de-register them for VAT purposes prior to my appointment. The other five companies were not registered for VAT.

No matters were expected to arise in respect of VAT, but I received a final VAT return for Capco CG 2010 Limited for the one day period 1 December 2014. The Companies' parent group confirmed this was a nil return and it was submitted to HMRC in January 2016.

EIS has now provided all PAYE and VAT clearances required and issued final nil proof of debt claims for all of the Companies

Sundry Receipt

In July 2016 I received notice that a business rates refund of some £10,000 was due to Capco CG 2010 Limited. The costs of opening a bank account for this company and dealing with its administration would not have been cost effective. Accordingly I requested that the refund be paid direct to the company's ultimate shareholder as this company would be the ultimate beneficiary of the funds. The payment was duly made.

Distributions

As previously stated, distribution in specie of the intercompany balances owed to the Companies were made prior to the final meetings of members being held



Liquidator's Remuneration

Pursuant to the insolvency Rules 1986, the Liquidator is obliged to fix his remuneration in accordance with Rule 4.148A(2) of the insolvency Rules 1986. This permits remuneration to be fixed either

- (1) as a percentage of the assets realised and distributed; and/or
- (2) by reference to the time the Liquidator and the staff have spent attending to matters in the liquidation, and/or
- (3) as a set amount, and/or
- (4) as a combination of the above

My remuneration was approved on a time costs basis on the date of my appointment. My staff and I have spent time on matters arising in the normal course of the liquidations. The main areas dealt with include

- liaising with the Companies in relation to matters prior to the Liquidator's appointment,
- statutory reporting requirements to members,
- statutory reporting requirements to the Registrar of Companies,
- dealing with statutory advertising requirements;
- regular updates to the Companies' parent group,
- correspondence with HMRC in order to obtain the necessary clearances to close the liquidations, including ensuring payments of liabilities and challenging penalties,
- dealing with creditor claims,
- preparing the annual progress reports;
- dealing with the business rates refund,
- considering the distribution of assets, and
- convening of the final meetings of members

Time costs for the entire duration of the liquidations to date total £24,172.7 represented by 63 25 hours of work carried out by myself and my staff at an average hourly rate of £382 18 as detailed by the enclosed time costs summaries. Time costs for the period under review total £10,873 70 represented by 21 75 hours of work at an average hourly rate of £499 94.

As agreed with the ultimate shareholder of the Companies, I have invoiced the sum of £23,750 plus disbursements and VAT to an appropriate associated company as none of the Companies held or holds any funds. No further costs will be drawn

Disbursements

Where disbursements are recovered in respect of precise sums expended to third parties there is no necessity for these costs to be authorised. These are known as category 1 disbursements.

The sum of £1,507 45 has been incurred in respect of category 1 disbursements for statutory advertising costs and the costs of the indemnity bonding, and have been invoiced as detailed above

Members' rights

I provide at the end of this report an extract from the Insolvency Rules 1986 setting out the rights of members to request further information and/or challenge the remuneration or expenses within the liquidations



Liquidation Closure

The shareholders were invited to consider the following resolutions

- 1 That the Liquidator's report and accounts to 9 December 2016 be and are hereby approved
- That the Liquidator is authorised to dispose of the Companies' books and records one year after the dissolution of the Companies
- 3 The Liquidator is released

Rule 4.49E Creditors' and members' request for further information

(1) If-

- (a) within the period mentioned in paragraph (2)-
 - (1) a secured creditor, or
 - (1) an unsecured creditor with the concurrence of at least 5% in value of the unsecured creditors (including the creditor in question), or
 - (iii) members of the company in a members' voluntary winding up with at least 5% of the total voting rights of all the members having the right to vote at general meetings of the company, or
- (b) with the permission of the court upon an application made within the period mentioned in paragraph (2)-
 - (I) any unsecured creditor, or
 - (11) any member of the company in a members' voluntary winding up,

makes a request in writing to the liquidator for further information about remuneration or expenses set out in a progress report in accordance with Rule 4 49B(1)(e) or (f) (including by virtue of Rule 4 49C(5)) or in a draft report under Rule 4 49D, the liquidator must, within 14 days of receipt of the request, comply with paragraph (3) except to the extent that the request is in respect of matter[s] in a draft report under Rule 4 49D or a progress report required by Rule 4 108 which (in either case) was previously included in a progress report not required by Rule 4 108

- (2) The period referred to in paragraph (1)(a) and (b) is-
 - (a) 7 business days of receipt (by the last of them in the case of an application by more than one member) of the progress report where it is required by Rule 4 108, and
 - (b) 21 days of receipt (by the last of them in the case of an application by more than one member) of the report or draft report in any other case
- (3) The liquidator complies with this paragraph by either-
 - (a) providing all of the information asked for, or
 - (b) so far as the liquidator considers that-
 - (1) the time or cost of preparation of the information would be excessive, or
 - disclosure of the information would be prejudicial to the conduct of the liquidation or might reasonably be expected to lead to violence against any person, or
 - (iii) the liquidator is subject to an obligation of confidentiality in respect of the information, giving reasons for not providing all of the information

Rule 4.148C Members' claim that remuneration is excessive

- (1) Members of the company with at least 10% of the total voting rights of all the members having the right to vote at general meetings of the company, or any member with the permission of the court, may apply to the court for one or more of the orders in paragraph (6) on the grounds that—
 - (a) the remuneration charged by the liquidator,
 - (b) the basis fixed for the liquidator's remuneration under Rule 4 148A, or



- (c) expenses incurred by the liquidator,
- is or are, in all the circumstances, excessive or, in the case of an application under sub-paragraph (b), inappropriate
- (2) Application must, subject to any order of the court under Rule 4 49E(5), be made no later than 8 weeks (or 4 weeks when the liquidator has resigned in accordance with Rule 4 142) after receipt by the applicant of the report or account which first reports the charging of the remuneration or the incurring of the expenses in question ("the relevant report")
- The court may, if it thinks that no sufficient cause is shown for a reduction, dismiss the application, but it must not do so unless the applicant has had the opportunity to attend the court for a hearing of which the applicant has been given at least 5 business days' notice but which is without notice to any other party
- (4) If the application is not dismissed under paragraph (3), the court must fix a venue for it to be heard and give notice to the applicant accordingly
- (5) The applicant must at least 14 days before the hearing send to the liquidator a notice stating the venue and accompanied by a copy of the application and of any evidence which the applicant intends to adduce in support of it
- (6) If the court considers the application to be well-founded, it must make one or more of the following orders—
 - an order reducing the amount of remuneration which the liquidator was entitled to charge,
 - (b) an order fixing the basis of remuneration at a reduced rate or amount,
 - (c) an order changing the basis of remuneration,
 - an order that some or all of the remuneration or expenses in question be treated as not being expenses of the liquidation,
 - (e) an order that the liquidator or the liquidator's personal representative pay to the company the amount of the excess of remuneration or expenses or such part of the excess as the court may specify,

and may make any other order that it thinks just, but an order under sub-paragraph (b) or (c) may be made only in respect of periods after the period covered by the relevant report

(7) Unless the court orders otherwise, the costs of the application must be paid by the applicant and are not payable as an expense of the liquidation
