ORDER

UPON the petition of BB Realisations (2018) Limited (in administration) (the "**Petitioner**") (acting through its joint administrators Peter David Dickens and Mark James Tobias Banfield) c/o PricewaterhouseCoopers LLP, 7 More London Riverside, London SE1 2RT, a creditor of the above-named GT News (Holdings) Limited, company number 06510628 (the "**Company**"), presented on 10 February 2023

AND UPON HEARING Anja Lansbergen-Mills of Counsel for the Petitioner and no one appearing on behalf of the Company

AND UPON READING the witness statements of Mark James Tobias Banfield dated 27 January 2023 and 23 February 2023 and the exhibits thereto

AND UPON IT APPEARING THAT the name of GT News (Holdings) Limited was struck off the Register of Companies pursuant to the provisions of section 1003(3) of the Companies Act 2006

AND there being no opposition on behalf of His Majesty to the relief sought by the said petition

AND THE COURT being satisfied that these proceedings are COMI proceedings to which the EU Regulation on Insolvency Proceedings as it has effect in the law of the United Kingdom applies

IT IS ORDERED THAT:

1. Pursuant to section 1029 of the Companies Act 2006 (the “**Companies Act**”), GT News (Holdings) Limited be restored to the Register of Companies under section 1031 of the Companies Act.
2. Pursuant to section 124 of the Insolvency Act 1986 (the “**Insolvency Act**”), GT News (Holdings) Limited be wound up by the Court under section 125 of the Insolvency Act.
3. The costs of the Petitioner be paid out of the assets of the Company.
