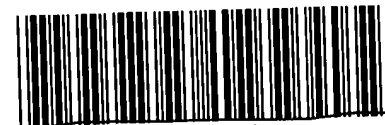


All the members have consented to the preparation of an abridged Profit and Loss and an abridged Balance Sheet in accordance with Section 444(2A) of the Companies Act 2006


