NO VOTING RIGHTS ATTACHED TO A SHARE MAY BE EXERCISED IN RELATION TO A WRITTEN RESOLUTION (TO BE PASSED IN ACCORDANCE WITH CHAPTER 13 OF THE COMPANIES ACT 2006) UNLESS ALL AMOUNTS PRESENTLY PAYABLE TO THE COMPANY IN RESPECT OF THAT SHARE HAVE BEEN PAID.
