Notes to the accounts

1 Accounting convention

The financial statements are prepared under the historical cost convention and in accordance with applicable accounting standards as defined in the Companies Act 2006 s.464.

2 Profit and loss account

No profit and loss account has been prepared as the Company has not traded during the year.

3 Statement of cash flows

The financial statements do not include a statement of cash flows because the Company, as small reporting entity, is exempt from the requirement to prepare such a statement under Section 7 of FRS 102.

4 Related party transactions

The Company has taken advantage of the exemption within Section 33 of FRS 102 (Related party disclosures) in not disclosing transactions with other wholly owned entities in the Saga group of companies.

5 Ultimate parent undertaking

The immediate parent undertaking at 31 January 2016 is Acromas Shipping Limited, a company which is registered in England and Wales. The Company is wholly owned by Acromas Shipping Limited

The financial statements of the company should be consolidated in the group financial statements of Acromas Holidays Limited (an intermediate parent undertaking) and Saga plc (the ultimate parent undertaking), both of which are registered in England and Wales.

In respect of the year ending 31 January 2016, Acromas Holidays Limited is the parent company of the smallest group of which the Company is a member and for which group financial statements are prepared.

6 Ultimate controlling party

The Directors consider the ultimate controlling party to be Saga plc.

7 Transition to FRS 102

As a dormant company, the Company has elected to take advantage of the transitional provisions of FRS 102 to retain its accounting policies for reported assets, liabilities and equity until there is any change to those balances, or the Company undertakes any new transactions.
