

On 23 April 2008, as a partner to The Enterprise No. 1 Partnership, the company made a capital contribution of £572,500 in accordance with the Partnership Agreement (PA).

On 3 April 2009, Baligay Limited purchased the entire 572,500 shares in Harold Wood Limited for £67,666. The directors consider this to be the most appropriate basis upon which to value the company's investment in The Enterprise No. 1 Partnership, and as such have written the investment down to this recoverable amount at 31 March 2009.
