On 18 September 2009, Baligay Limited purchased the entire 916,000 shares in Leonard Jay Productions Limited for £108,265. The directors consider this to be the most appropriate basis upon which to value the company's investment in The Enterprise No. 1 Partnership, and as such have written the investment down to this recoverable amount at 31 March 2009.
