**DRAFT** ORDER

UPON the joint applications of Guy Charles Harrison and Paul Anthony Higley by application notice dated 10th April 2012

AND UPON reading the evidence filed

#### IT IS ORDERED THAT:-

1 In respect of those of the administrations, compulsory liquidations, creditors voluntary liquidations, members voluntary liquidations, individual voluntary arrangements, company voluntary arrangements and bankruptcies identified in Schedules 1, 2 and 3 annexed hereto and being the subject of proceedings in any other court than the High Court, those proceedings be transferred to the Chancery Division of the High Court for the purpose of making the orders contained in paragraphs 2 to 10 below

- 2 The cases transferred pursuant to paragraph 1 be transferred back to the court from which they were transferred immediately after the making of this order.
- 3 The First Applicant, First Respondent and Second Respondents be removed from office as administrator, liquidator, supervisor and trustee in bankruptcy (as the case may be) of the administrations, creditors voluntary liquidations, members voluntary liquidations, individual voluntary arrangements and bankruptcies as set out in Schedules 1, 2 and 3 attached
- 4 The Second Applicant, Paul Anthony Higley, be appointed as office holder in place of the First Applicant in respect of the administrations, compulsory liquidations, creditors voluntary liquidations, individual voluntary arrangements and bankruptcies listed at Schedule 1
- 5 The Second Applicant, Paul Anthony Higley be appointed as office holder, jointly with the First Respondent, in place of the First Applicant in respect of the administrations, compulsory liquidations, creditors voluntary liquidations, individual voluntary arrangements and bankruptcies listed at Schedule 2
- The Second Applicant, Paul Anthony Higley be appointed as office holder in place of the Second Respondent in respect of the administrations, compulsory liquidations, creditors voluntary liquidations, individual voluntary arrangements and bankruptcies listed at Schedule 3.
- 7 All appointments made herein be advertised in the London Gazette and such advertisement shall constitute sufficient notice to all creditors except the appointment made under the individual voluntary arrangements when notice shall be sent to all creditors bound by the arrangements when the next annual report is due to creditors, such notice to include the following matters -
  - (a) An explanation of the effect of this Order,
  - (b) Express reference to the livery to apply set out in paragraph 8 below,
  - (c) The provision of all such information as might reasonably be required with regard to the conduct of the arrangements
- 8 Liberty to apply to each creditor of each administration, members voluntary liquidation, individual voluntary arrangement, company voluntary arrangement and bankruptcy to apply to vary or discharge this order within 21 days of receipt of the notices directed to be given under paragraph 5 above.
- 9 The basis of remuneration of the Applicants shall remain the same as previously approved by the creditors in each of the appointments
- 10 No order as to costs
