Members have not required the Company to obtain an audit for the year in question in accordance with section 476 of the Companies Act 2006.

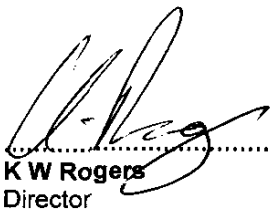

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MAY 2018

1. General information

Wilson Browne Solicitors Limited is a company limited by shares, domiciled in England and Wales, registered number 06588792. The registered office and principal place of business is Kettering Parkway South, Kettering Venture Park, Kettering, Northants, NN15 6WN.

2. Accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention unless otherwise specified within these accounting policies and in accordance with Section 1A of Financial Reporting Standard 102, the Financial Reporting Standard applicable in the UK and the Republic of Ireland and the Companies Act 2006.

2.2 Cash and cash equivalents

Cash is represented by cash in hand and deposits with financial institutions repayable without penalty on notice of not more than 24 hours. Cash equivalents are highly liquid investments that mature in no more than three months from the date of acquisition and that are readily convertible to known amounts of cash with insignificant risk of change in value.
