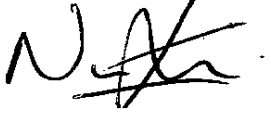

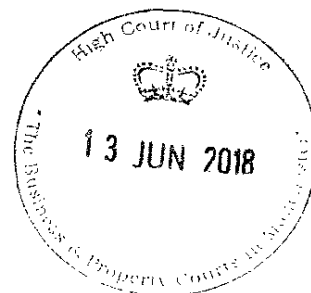

ORDER

UPON THE APPLICATION dated 4 June 2018

AND UPON READING the Witness statement of Howard Smith dated 4 June 2018

IT IS ORDERED THAT:

1. Such of the insolvency proceedings set out in the attached Schedules that are proceeding in any Court other than this Court be transferred to this Court for the purposes of this Application *and thereafter be transferred back to that Court.*
2. Pursuant to sections 13 and 19 and paragraphs 63, 88, 91 and 95 of Schedule B1 to the Insolvency Act 1986 (the **Act**) and rule 12.36 of the Insolvency (England and Wales) Rules 2016 (the **Rules**):
 - (a) Paul Andrew Flint be removed from office as Administrator of the companies listed in Schedule 1A and Paul Nicholas Dumbell be appointed as Administrator of those companies.
 - (b) Paul Andrew Flint be removed from office as Administrator of the company listed in Schedule 1B and David James Costley-Wood be appointed as Administrator of that company.
 - (c) Paul Andrew Flint and Jonathan Charles Marston be removed from office as Administrators of the company listed in Schedule 1C and Paul Nicholas Dumbell and Howard Smith be appointed as Administrators of that company.
 - (d) Jonathan Charles Marston be removed from office as Administrator of the companies listed in Schedule 1D and David James Costley-Wood be appointed as Administrator of those companies.
 - (e) Jonathan Charles Marston be removed from office as Administrator of the company listed in Schedule 1E and Mark Jeremy Orton be appointed as Administrator of that company.
 - (f) Jonathan Charles Marston be removed from office as Administrator of the company listed in Schedule 1F and Paul Nicholas Dumbell be appointed as Administrator of that company.
3. Pursuant to sections 13 and 19 and paragraphs 63, 88, 91 and 95 of Schedule B1 to the Act as modified by article 6(1) and paragraphs 32 and 35 of Schedule 2 of the Insolvent Partnerships Order 1994 and rule 12.36(2) of the Rules:
 - (a) Paul Andrew Flint be removed from office as Administrator of the partnership listed in Schedule 1G and Paul Nicholas Dumbell be appointed as Administrator of that partnership.

4. Pursuant to section 108 of the Act and rule 12.36(2) of the Rules:
 - (a) Paul Andrew Flint be removed from office as Liquidator of the companies listed in Schedule 2A and Paul Nicholas Dumbell be appointed as Liquidator of those companies.
 - (b) Paul Andrew Flint be removed from office as Liquidator of the company listed in Schedule 2B and David John Standish be appointed as Liquidator of that company.
 - (c) Jonathan Charles Marston be removed from office as Liquidator of the companies listed in Schedule 2C and David James Costley-Wood be appointed as Liquidator of those companies.
 - (d) Jonathan Charles Marston be removed from office as Liquidator of the company listed in Schedule 2D and Howard Smith be appointed as Liquidator of that company.
5. Pursuant to section 108 of the Act and rule 12.36(2) of the Rules:
 - (a) Paul Andrew Flint be removed from office as Liquidator of the companies listed in Schedule 3 and Nicholas James Timpson be appointed as Liquidator of those companies.
6. Pursuant to sections 168(3) & (5) and 172(2) of the Act and rule 12.36(2) of the Rules:
 - (a) Paul Andrew Flint be removed from office as Liquidator of the company listed in Schedule 4 and Paul Nicholas Dumbell be appointed as Liquidator of that company.
7. Pursuant to section 7(5) and paragraph 39(6) of Schedule A1 of the Act and rule 12.36 of the Rules:
 - (a) Jonathan Charles Marston be removed from office as Supervisor of the company listed in Schedule 5 and Paul Nicholas Dumbell be appointed as Supervisor of that company.
8. That in the case of each company and partnership identified in the Schedules the officeholders appointed or continuing in office, (as identified in those Schedules) will cause notice of the change in office holders to be:
 - (a) given to the Secretary of State for Business, Energy and Industrial Strategy within 14 days of the date of this order;

- (b) advertised in the London Gazette or other appropriate publication within 14 days of the date of this order, such advertisement to include an explanation of the effect of the order and notice that any creditor may within 28 days of the advertisement of the order make an application to Court to challenge the order; and
 - (b) included in their next written report to creditors of the estates listed in the Schedules.
- 9. Pursuant to paragraph 98(2)(c) of Schedule B1 of the Insolvency Act 1986, the First and Second Applicants be discharged from liability in respect of their actions as Administrators of the companies listed in Schedule 1A to 1G, as applicable:
 - (i) If no application is made pursuant to paragraph 12 below, on the date being 28 days from the date of the advertisement referred to in paragraph 8(b) above, or
 - (ii) If an application is made pursuant to paragraph 12 below, at such time as should be subsequently ordered by the Court.
- 10. The First and Second Applicants shall receive their release (pursuant to s173(2)(b) and s174(4)(b) of the Insolvency Act 1986) as Joint Liquidator of the companies listed in Schedules 2A to 2C, Schedule 3 and Schedule 4 as applicable, 28 days from the date of the advertisement referred to in paragraph 8(b), save that such release may be subject to further order in the event of an application by any creditor under paragraph 12 of this order for the specific case subject to that application.
- 11. Pursuant to Rule 12.10 of the Rules the need to serve the Application upon the Respondents be dispensed with.
- 12. There be liberty for each creditor or member of the companies or partnership listed in the attached Schedules to apply to vary or discharge this Order in so far as it relates to a company or partnership of which that person is a creditor or member within 28 days of the publication of an advertisement in relation to that company in accordance with paragraph 8(b) above.
- 13. There be no order as to costs.
