I confirm that I have not received any remuneration in this matter and all expenses paid are detailed in the enclosed receipts and payments account I would draw to your attention to rules 4 49E and 4 131 of The Insolvency Rules 1986. Under rule 4 49E a secured creditor, or an unsecured creditor with the concurrence of at least 5% in value of the creditors, or any creditor with the permission of court, may within 21 days of receipt of this report, request in writing further information concerning the liquidator's remuneration or expenses. Under rule 4 131 a secured creditor, or an unsecured creditor with either the concurrence of at least 10% of the value of creditors or the permission of court, may apply to court within 8 weeks of receipt of this report, on the grounds that the remuneration charged, the basis fixed, or the expenses incurred are excessive or inappropriate.
