

**1. STATUTORY INFORMATION**

27 Lindore Road Management Co Limited is a private company, limited by shares, registered in England and Wales. The company's registered number is 06613510 and its registered address is 27 Lindore Road, London, SW11 1HJ.

The company is entitled to exemption from audit under Section 477 of the Companies Act 2006 for the period ended 31 December 2018.

The members have not required the company to obtain an audit of its financial statements for the period ended 31 December 2018 in accordance with Section 476 of the Companies Act 2006.
