NOTES TO THE ABBREVIATED ACCOUNTS FOR THE YEAR ENDED MARCH 31, 2015

1. Accounting policies

Basis of accounting

The financial statements have been prepared under the historical cost convention and in accordance with applicable United Kingdom accounting standards, the Statement of Recommended Practice "Accounting and Reporting by Charities" issued in March 2005 (SORP 2005) and the Companies Act 2006.

Cash flow statement

The trustees have taken advantage of the exemption in Financial Reporting Standard No 1 (revised) from including a cash flow statement in the Financial Statements on the grounds that the Company is small.

Fixed assets

All fixed assets are initially recorded at cost.

Fund accounting

Income which relates to a specific fund and purpose is accounted for by preparing individual accounts. Surpluses and deficits relating to funds received on an annual or specific basis which are available for use at the discretion of the trustees are considered to be unrestricted. Where the terms of the service agreement define exclusive use of the income, the fund is classified as a restricted income fund.

2. Company Limited by guarantee

The company is limited by guarantee and as such has no share capital. The liability of the members of the company, as set out in the Memorandum of Association is limited to £10 per member in the event of the company being wound up whilst they are a member or within one year of ceasing to be a member.
