ORDER

UPON the application of Robert Neil Dymond for a block transfer order pursuant to Insolvency (England and Wales) Rules 2016 r.12.36

AND UPON READING the evidence filed

AND UPON the Applicant inviting the court to consider the application without a hearing and the court being satisfied that it is an appropriate case for a substantive order to be made on the application without a hearing

IT IS ORDERED

1. Such of the insolvency proceedings listed in the Schedules to this order which are not currently before the High Court of Justice, Business and Property Courts in Leeds, Insolvency and Companies List (ChD) be transferred to this court for the purposes only of the application for a block transfer order and thereafter be transferred back to their respective courts.

2. From the date of this order Robert Neil Dymond be removed from office as trustee in bankruptcy of the individuals listed in Schedule 1 and Kelly Anne Burton be appointed as joint trustee in bankruptcy of those individuals.

3. From the date of this order Robert Neil Dymond be removed from office as supervisor of the individual voluntary arrangements of the individuals listed in Schedule 2 and Kelly Anne Burton and ~~Fiona Clare Grant~~ be appointed as joint supervisor of those individual voluntary arrangements.



4. From the date of this order Robert Neil Dymond be removed from office as joint administrator of the companies listed in Schedule 3 and Joseph Fox be appointed as joint administrator of those companies.

5. From the date of this order Robert Neil Dymond be removed from office as joint liquidator of the companies in compulsory liquidation listed in Schedule 4 and the individuals listed in the final column of that schedule be appointed as joint liquidator of those companies.

6. From the date of this order Robert Neil Dymond be removed from office as joint liquidator of the companies in creditors' voluntary liquidation listed in Schedule 5 and the persons named in that schedule as the replacement for Robert Neil Dymond (as either lead or second IP) be appointed as joint liquidator of those companies.

7. From the date of this order Robert Neil Dymond be removed from office as joint liquidator of the companies in members' voluntary liquidation listed in Schedule 6 and the persons named in that schedule as the replacement for Robert Neil Dymond (as either lead or second IP) be appointed as joint liquidator of those companies.

8. Provided that no application has been made pursuant to paragraph 15 of this order in respect of the administration in question, pursuant to paragraph 98(2)(c) Robert Neil Dymond be discharged from liability in respect of any actions of his as administrator of the companies listed in Schedule 3 28 days after notice has been given in accordance with paragraph 13 of this order.

9. Save as provided for in paragraph 8 above any application for release shall be made to the Secretary of State pursuant to section 173, 174 or 299 of the Insolvency Act 1986 as appropriate.

10. In any case where the Replacement Office Holders are taking an office which will be jointly held by more than one person any act required or authorised under any enactment to be done

by the office-holder may be done by any one or more of the persons for the time being holding the office in question.

11. Pursuant to rule 12.38(3) of the said rules the Applicants shall ensure that a sealed copy of this order is filed with the court having jurisdiction over each case.
12. Pursuant to rule 12.38(6) of the said rules the Replacement Office Holders shall give written notice of their appointment to the Secretary of State in all cases and also to the Registrar of Companies in the cases of liquidations, administrations and company voluntary arrangements.
13. Pursuant to rule 12.38(6) of the said rules the Applicant shall give written notice of this order to the creditors in all cases and also to the members in the case of members' voluntary liquidations as follows:
 - (a) in the next progress report; and
 - (b) by way of one composite advertisement in the London Gazette within 28 days of the date of this ordersuch notices to include an explanation of the effect of this order and express reference to the liberty to apply in paragraph 15 of this order.
14. The time by which the progress reports in each case are required to be delivered shall be unaffected by the change in office holder unless the court otherwise orders in any individual case.
15. The creditors in all cases and the companies / individuals in the case of the voluntary arrangements have liberty to apply to set aside or vary this order within 28 days of the date of posting the progress report containing written notice of this order.
16. So much of the Applicant's application which seeks an order entitling the Respondents to charge to each individual estate the costs of obtaining an Insolvency Practitioner's licence bond in respect of that estate is dismissed.
17. This order shall be served by the Applicant on the Respondents.
18. No order as to costs

19. The court has made this order of its own initiative without hearing the parties or giving them an opportunity to make representations. Any party affected by the order may apply to have it set aside, varied or stayed providing application is made not later than 4pm on the date 7 days after service of this order upon them.

Reasons

I am satisfied that the conditions for a block transfer order are made out. I decline to permit the Respondents to charge the costs of obtaining their bonds to each individual estate on the basis that I cannot see the justification for doing so in circumstances where the Applicant's evidence does not make out a case for the same in circumstances where he is vacating office for his own reasons.
