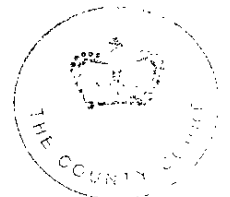
AND on the Claimants having complied with the requirements of the Registrar of Companies by bringing up to the date the Company's public file with the filing of outstanding Statutory Returns

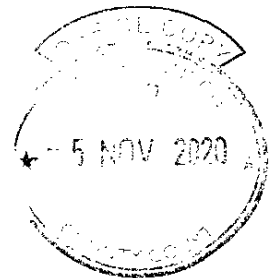

name in the "London Gazette"




