



On 24 July 2008, as a partner in The Vanguard No. 1 Partnership, the company made a capital contribution of £287,500 in accordance with the Partnership Agreement (PA).

On 14 January 2009, as a partner in The Vanguard No. 1 Partnership, the Company made a capital contribution of £314,080 in accordance with an Additional Contribution Agreement.

On 19 February 2009, as a partner in The Vanguard No. 1 Partnership, the Company made a capital contribution of £89,518 in accordance with an Additional Contribution Agreement.

On 2 April 2009, Baligay Limited purchased the entire 232,000 shares in Daivat 2 Ltd for £94,436. The directors consider this to be the most appropriate basis upon which to value the company's investment in The Vanguard No. 1 Partnership, and as such have written the investment down to this recoverable amount at 31 March 2009.
