Notes to the Accounts: 30th June 2021

1. During the year an annual news and fund-raising letter to Friends and Trustees was sent out. In these Annual Accounts, it was decided to eliminate the distinction between bursaries received, designated giving, and memberships, and show one figure: £7,824. KMS is advised annually of the amount received for Bursaries.

Also during the year, Kampala Music School itself was not allowed to open for normal lessons, but some teachers have continued to teach some pupils on-line by Zoom. Teachers have also given lessons on Zoom to pupils in UK, Brussels and elsewhere (£660). There are still needs at KMS both for Bursaries to enable pupils who cannot afford fees to receive lessons, and for Income/Budget support for KMS. Doors were opened again in early January 2022.

- 2. "Notes from Uganda" was written by KMS Founder, Fiona Carr, telling the story of the Kampala Music School. Some 700 copies were printed, and 264 (3 boxes) sent to Kampala. In UK, many were sold but some given away free of charge. A number of donations were received because of it. Income shown is £2,466 and expenditure £2,415. Further books continue to be sold and a few are still available.
- 3. Global Giving was a valuable way to transfer funds to KMS, as extra was received by FKMS here in UK (£500) and 50% more than the amount sent (£5,000) by KMS.
- 4. Revenue Surplus on I&E Account: This is made up of annual surpluses less deficits to 30th June 2021.

Objectives of FKMS

Under the Memorandum of Association of the Company/Charity, the primary purpose is to advance the study of music in Uganda; in addition to send instruments, help develop suitable premises, and generally to support Kampala Music School. FKMS also seeks to find volunteers to help at the School in the short term, if requested.

Finances

The accounts show gross income of £12,125 (2020: £13,299) and expenditure of £10,141 (2020: £8,859). Of the expenditure, £6,628 was remitted to KMS (2020: £8,087).

FKMS Plans for 2021/22

As mentioned in Note 1 (p4) the requirements for FKMS to raise funds continue at the level shown. On-going requirements will be as in previous years. In order to maintain the goodwill of the many who have helped with gifts in the past, newsletters are sent out at least annually and responses are forthcoming.
