The declaration of solvency, sworn by the directors prior to the commencement of the liquidation, showed a debt totalling £1 due from BOP (99 Bishopsgate) SARL, the Company's immediate parent.

The Company had no known creditors. A notice to creditors to prove their claims in the liquidation was advertised in the London Gazette on 11 August 2016. No creditors were forthcoming as a result of this advertisement.

CIS registration/penalties

HMRC issued an interim claim totalling £20,301.25 in respect of CIS penalties that were levied against the Company for the period 4 October 2012 to 5 January 2015.

They have stated that the Company's CIS registration ceased on 4 August 2015, however, the Liquidators were advised the Company disposed of its investment property in 2012. The Liquidators are currently liaising with HMRC and investigating this matter.

Tax

All pre-liquidation corporation tax matters were handled by KPMG Tax who prepared and submitted all outstanding returns up to the date of the commencement of the liquidation to HM Revenue & Customs ("HMRC"). The Liquidators sought confirmation from HMRC that the Company had no outstanding corporation tax returns or liabilities, that it would not raise enquiries into any pre or post liquidation periods and that it had no objection to the Liquidators taking steps to bring the liquidation to a conclusion. A response is still awaited.

A similar assurance was sought and is awaited from HMRC in respect of PAYE and VAT matters.
