The Directors, being eligible, offer themselves for re-election to the board at the next Annual General Meeting of the Company.

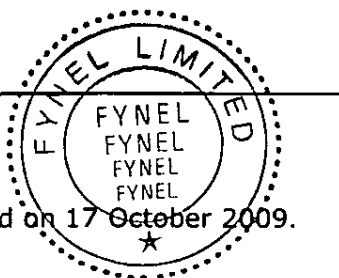
RESPONSIBILITY

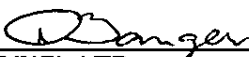

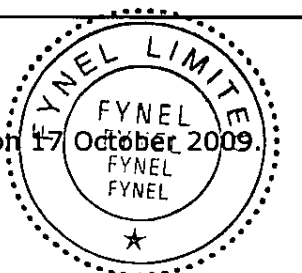

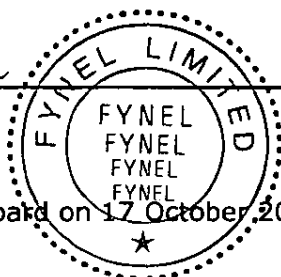
