1. Introduction

Leigh Holmes and Susan Purnell of Purnells, Goldfields House, 18A Gold Tops, Newport, South Wales, NP20 4PH were appointed Joint Liquidators of Castlegate 535 Limited on 6 August 2019, by Deemed Consent.

There have been no changes in office holders during the period.

2. Receipts And Payments Account

- 2.1 A Receipts and Payments Account is attached at Appendix 2.
- 2.2 The receipts and payments account, compares the actual realisations made to date, with the estimated realisations set out in the director's Statement of Affairs.

3. Assets

3.1 There have been no realisations since the date of our last report.

4. Investigations

- 4.1 At the time of our last report preliminary investigations had been undertaken, but further analysis was required.
- Further enquiries have been made and some of the queries raised have now been resolved. As certain queries remain unanswered the matter remains ongoing.
- 4.3 We have completed our statutory obligation, by submitting a report to the Insolvency Service as to the conduct of the directors. The contents of this report have to remain confidential.

5. Cost of the Liquidation

- 5.1. The Receipts and Payments Account at Appendix 2, sets out details of the payments made to date.
- 5.2. An explanation as to the fees sought by the Joint Liquidators was circulated on 13 August 2019.
- 5.3. The Joint Liquidators requested that they be remunerated as follows:-

- 5.4. Creditors agreed the Liquidators' remuneration on the above basis, by way of correspondence.
- 5.5. The sum of £9,500 has been drawn to date. No fees have been drawn since the date of our last report,
- 5.6. It was also agreed by creditors, by way of correspondence, that Purnells receive a Statement of Affairs Fee of £6,000 plus VAT for the work done, up to and including the date of appointment and that the Joint Liquidators may charge Category 2 disbursements of 40p per mile for site visits.

6. Creditors Rights

- 6.1. Secured Creditors and Unsecured Creditors with the concurrence of at least 5% in value of the Unsecured Creditors, including the creditors in question, have the right under Rule 18.9 of the Insolvency Rules 2016 to request further information about remuneration or expenses set out in the Progress Report. An Unsecured Creditor with the permission of the court also has this right. The request must be made within 21 days of the receipt of the report.
- 6.2. Secured Creditors and Unsecured Creditors with the concurrence of at least 10% in value of the Unsecured Creditors, including that creditor, or with the permission of the court have the right under Rule 18.34 of the Insolvency Rules 2016 to challenge the Liquidators remuneration, no later than 8 weeks following receipt of the report.

7. Return to Creditors

- 7.1 Following our appointment it was agreed that Tilon CG Ltd would pay the arrears owed to the employee's pension scheme.
- 7.2 Although Tilon CG Ltd paid the amount due to the schemes it came to light that a direct debit payment, made by Castlegate 535 Limited prior to cessation, had not cleared the Company's bank account, leaving further arrears to the scheme.
- 7.3 Although it took a considerable amount of time to establish, from the scheme provider, the exact amounts owed, once this was established we submitted a claim to The Insolvency Service, for payment from The National Insurance Fund.
- 7.4 A payment totaling £2,303 was duly made into the scheme by The Insolvency Service.
- 7.5 A formal notice of claim has not yet been received from The Insolvency Service. However it is anticipated that this will be split £1,439 preferential and £864 unsecured.
- 7.6 We have not formally requested claims from creditors at this time, as a dividend will only be paid should our unanswered queries give rise to recoveries.

8. Conclusion

The liquidation remains open to finalise our investigations into the financial affairs of the Company. It is anticipated all matters will be concluded within six months.
