The declaration of solvency, sworn by the directors prior to the commencement of the liquidation, showed neither assets nor liabilities.

The Company had no known creditors. A notice to creditors to prove their claims in the liquidation was advertised in the London Gazette on 6 October 2016. No creditors were forthcoming as a result of this advertisement.

## Tax

A corporation tax enquiry for the year ended 31 December 2013, that was ongoing at the commencement of the liquidation, was completed by HM Revenue and Customs ("HMRC") on 6 September 2017, with no amendments required.

All pre-liquidation corporation tax matters were handled by the company's tax agents who prepared and submitted all outstanding returns up to the date of the commencement of the liquidation to HMRC. The Joint Liquidators have subsequently requested and received confirmation from HMRC that the Company has no outstanding corporation tax returns or liabilities, that it will not raise enquiries into any pre or post liquidation periods and that it has no objection to the Liquidators taking steps to conclude the liquidation.

A similar assurance was sought and received from HMRC in respect of PAYE and VAT matters.

## Distributions

There were no assets available for distribution to shareholders.

## Joint Liquidators' remuneration and expenses

A written resolution was passed on 27 September 2016 that the remuneration of the Joint Liquidators be fixed at their normal charging rates according to the time properly spent by them and members of their staff in attending to matters arising in the winding up of the Company.
