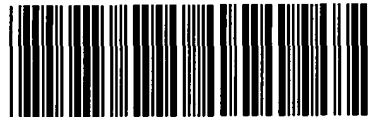



Notes to the Financial Statements

Period ended 30 September 2022

1. General information

The company is a private company limited by shares, registered in England and Wales. The address of the registered office is Inkerman House, St John's Road, Meadowfield, Durham, DH7 8XL.

2. Statement of compliance

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland'.

3. Accounting policies

(a) Basis of preparation

The financial statements for the period have been prepared for the period from 4 October to 30 September 2022 (2021: 53 week period ended 3 October 2021), on the going concern basis under the historical cost convention and in accordance with applicable accounting standards in the United Kingdom. The financial statements are prepared in GBP sterling which is the functional currency of the company.

(b) Disclosure exemptions

In these financial statements, the company has applied the exemptions available under FRS 102 in respect of the following disclosures:

- the requirements of Section 4 Statement of Financial Position paragraph 4.12(a)(iv)
- the requirements of Section 7 Statement of Cashflows
- the requirement of Section 11 Basic Financial Instruments paragraphs 11.41 to 11.48c
- the requirement of Section 33 Related Party Disclosures 33.1A and 33.7

The group in which the results of the Company are consolidated is Banks Group Holdings Limited. Copies of the Banks Group Holdings financial statements can be obtained from its registered office, Inkerman House, St. John's Road, Meadowfield Industrial Estate, Durham, DH7 8XL.

(c) Income statement

The company is dormant as defined by section 1169 of the Companies Act 2006. The company received no income and incurred no expenditure during the current period or prior period and therefore no income statement is presented within these financial statements. There have been no movements in shareholders' funds during the current period or prior period.

(d) Judgements and key sources of estimation uncertainty

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the amounts reported for assets and liabilities as at the Statement of Financial Position date and the amounts reported for revenues and expenses during the period. However, the nature of estimation means that the actual outcomes could differ from those estimates. There are no material judgements and areas of uncertainty that could have a significant effect on amounts recognised in the financial statements.

4. Employees and directors' remuneration

The company had no employees during the current or prior period.

6. Ultimate controlling party

The company is a wholly owned subsidiary of H. J. Banks and Company Limited, which is itself a wholly owned subsidiary of Banks Group Holdings Limited, the ultimate holding company. Both of these companies are incorporated in England. Banks Group Holdings Limited is the only group of undertakings for which Group financial statements are drawn up. The Group financial statements can be obtained from the registered office. Mr H J Banks is the controlling party by virtue of his controlling interest in the equity share capital of Banks Group Holdings Limited.
