The authority given by this resolution shall expire on the date that any obligation incumbent on the Company to allot shares in respect of which authority is given by this resolution terminates in accordance with the terms of the relevant obligation.
- That the directors of the Company are authorised by this resolution to issue up to 705 Shares on the exercise of warrants to subscribe for Shares issued to those persons who have subscribed for Further Loan Notes. The obligation to offer shares on a pre-emptive basis contained in 2.2 and 2.3 of the Articles shall for all purposes be dis-applied in relation to these shares. The authority given by this resolution shall expire on the date that any obligation incumbent on the Company to allot shares in respect of which authority is given by this resolution terminates in accordance with the terms of the relevant obligation.
