SUPPLEMENTAL DEBENTURE

THIS SUPPLEMENTAL DEBENTURE IS SUPPLEMENTAL TO THE TERMS OF A
DEBENTURE DATED 24 APRIL 2015 BETWEEN THE CHARGOR, CLINIGEN
HEALTHCARE LIMITED, CLINIGEN CLINICAL TRIALS LIMITED, CLINIGEN CTS LIMITED
AND THE SECURITY AGENT

THIS SUPPLEMENTAL DEBENTURE is made on 3 August 2017

BETWEEN:-

- (1) **CLINIGEN GROUP PLC** (company number 06771928) (the "**Chargor**"); and
- (2) **THE ROYAL BANK OF SCOTLAND PLC** as agent and trustee for itself and each of the Finance Parties (the "**Security Agent**").

RECITALS

- (A) This Supplemental Debenture is supplemental to the Debenture dated 24 April 2015 between the Chargor, Clinigen Healthcare Limited, Clinigen Clinical Trials Limited, Clinigen CTS Limited and the Security Agent (the "**Debenture**").
- (B) The Chargor holds the shares in Clinigen Asia Pte Limited (formerly known as Link Healthcare Private Ltd), a company registered in Singapore with registration number 201203724K details of which are set out in the Schedule (the "**Additional Shares**").
- (C) The Chargor's interest in the Additional Shares shall be added to the existing Shares charged by Clause 3.1.3 of the Debenture.
- (D) The Security Agent and the Chargor intend this Supplemental Debenture to, and it shall, take effect as a Deed.

IT IS AGREED as follows:-

1. INTERPRETATION

- 1.1 In this Supplemental Debenture (including the Recitals), unless there is something in the subject matter or context inconsistent with the Debenture, words and expressions shall have the same meanings as set out in the Debenture and the other construction provisions contained in the Debenture shall apply to this Supplemental Debenture.
- 1.2 For the avoidance of doubt the Additional Shares shall form part of the "Charged Property" for the purposes of interpretation of the Debenture.

2. COVENANT TO PAY

The Chargor covenants that it will on demand of the Security Agent pay and discharge any or all of the Secured Liabilities when due in accordance with the terms of the Facilities Agreement.

3. SECURITY

- 3.1 The Chargor as continuing security for its obligations and with full title guarantee, without prejudice to the terms of, and all rights and interests arising under or pursuant to, the Debenture, hereby grants to the Security Agent an equitable mortgage or (if or to the extent that this does not take effect as a mortgage) a first fixed charge over the Additional Shares.
- 3.2 The Chargor agrees that the Additional Shares shall be included in the definition of "Shares" for all purposes of the Debenture.

4. INCORPORATION OF DEBENTURE

The Chargor and the Security Agent hereby agree that:

- 4.1 all of the obligations, undertakings, covenants, rights and powers specified and contained in the Debenture which relate to the property referred to in, and the security

and other rights and powers created under and pursuant to, the Debenture shall be deemed to be repeated in this Supplemental Debenture and shall apply to the rights and property referred to in Clause 3 above; and

- 4.2 the security and other rights and powers created under and pursuant to this Supplemental Debenture and that the whole remaining terms of the Debenture shall, except in so far as inconsistent with this Supplemental Debenture, apply to this Supplemental Debenture, provided always that this Supplemental Debenture shall be without prejudice to the Debenture and all of the rights, powers, obligations and immunities comprised therein and arising pursuant thereto, which shall remain in full force and effect notwithstanding this Supplemental Debenture.

5. **GOVERNING LAW**

This Supplemental Debenture and any non-contractual obligations arising out of or in connection with it shall be governed by and construed in accordance with English law.
