IT IS ORDERED THAT:

1. The insolvency proceedings listed in the Schedules attached hereto which are not currently before the High Court of Justice ("High Court") be transferred to the High Court for the purposes of the Application only, and the Applicant shall ensure that a sealed copy of this Order be lodged with the Court having jurisdiction over each case affected by this Order and is notified to the Secretary of State.

- 2. The Applicant, Peter John Godfrey-Evans, is removed from his office as Liquidator in respect of the company in Creditors' Voluntary Liquidation which is set out in Schedule A attached hereto.
- 3. The First Respondent, Henry Nicholas Page, is appointed as Liquidator in substitution of the Applicant in respect of the company which is set out in Schedule A attached hereto.
- 4. The Applicant, Peter John Godfrey-Evans, is removed from his office as Liquidator in respect of the companies in Members' Voluntary Liquidation which are set out in Schedule B attached hereto.
- 5. The First and Second Respondents, Henry Nicholas Page and Dominic Paul Dumville, are appointed as Liquidator in substitution of the Applicant in respect of the companies which are set out in Schedule B attached hereto where they are identified as proposed appointee.
- 6. The Applicant, Peter John Godfrey-Evans, is removed from his office as Trustee in Bankruptcy in respect of the individual who is set out in Schedule C attached hereto.
- 7. The Second Respondent, Dominic Paul Dumville, is appointed as Trustee in Bankruptcy in substitution of the Applicant in respect of the individual who is set out in Schedule C attached hereto.
- 8.
