The declaration of solvency, sworn by the directors prior to the commencement of the liquidation, showed a debt due from Aegon UK Distribution Holdings Limited ("AUKDHL"), the Company's immediate parent. The debt has been distributed by set off (see "Distributions" below)

The Company had no known creditors A notice to creditors to prove their claims in the liquidation was advertised in The London Gazette and The Independent newspaper on 1 October 2012 No creditors were forthcoming as a result of this advertisement

### Tax

All pre-liquidation corporation tax matters were handled by Aegon who prepared all outstanding returns up to the date of the commencement of the liquidation. These were submitted to HM Revenue & Customs ("HMRC") by the liquidator and HMRC subsequently confirmed that the Company had no outstanding corporation tax returns or liabilities, that it would not raise enquiries into any pre or post liquidation periods and that it had no objection to the liquidator calling a final meeting of members to conclude the liquidation

#### Distributions

On 11 June 2013 the liquidator declared a first and final distribution of the assets of the Company to AUKDHL, as the sole beneficial shareholder of the Company

The distribution was a distribution in specie of the debt of £435,509 due to the Company by AUKDHL

#### Liquidator's remuneration and expenses
