ORDER

UPON the application of Laura Jane Prescott ("**Applicant**") dated 19 August 2019 for a Block Transfer Order in relation to the appointments of Brendan P Hogan ("**Respondent**")

AND UPON READING the witness statements of the Applicant dated 19 August 2019 in support of the Application and the Respondent dated 19 August 2019 confirming that he has no objection to the Application

IT IS ORDERED that

1. The cases listed in schedules 1 to 5 attached to this Application ("**the Schedules**"), in so far as they are currently proceedings in a County Court, those proceedings be transferred to the High Court, Business and Property Courts in Manchester to be dealt with as Insolvency and Companies List business, solely for the purpose of hearing the application for the orders sought below.
2. In respect of each creditors' voluntary liquidation referred to in Schedule 1 the Respondent be removed pursuant to Section 108 of the Insolvency Act 1986 ("**the Act**") from the office of liquidator of the relevant company with immediate effect and

the Applicant shall be appointed as liquidator of the relevant company in place of the Respondent with immediate effect.

3. In respect of each members' voluntary liquidation referred to in Schedule 2 the Respondent be removed pursuant to Section 108 of the Act from the office of liquidator of the relevant company with immediate effect and the Applicant shall be appointed as liquidator of the relevant company in place of the Respondent with immediate effect.
4. In respect of each company voluntary arrangement referred to in Schedule 3 the Respondent be removed pursuant to Section 7(5) and paragraph 39(6) of Schedule A1 of the Act from the office of supervisor of the relevant company voluntary arrangement with immediate effect and the Applicant shall be appointed as supervisor of the relevant company voluntary arrangement in place of the Respondent with immediate effect.
5. In respect of each bankruptcy estate referred to in Schedule 4 the Respondent be removed pursuant to Section 298 of the Act from the office of trustee in bankruptcy of the relevant bankruptcy estate with immediate effect and the Applicant shall be appointed as trustee in bankruptcy of the relevant bankruptcy estate in place of the Respondent with immediate effect.
6. In respect of each individual voluntary arrangement referred to in Schedule 5 the Respondent be removed pursuant to Section 263(5) of the Act from the office of supervisor of the relevant individual voluntary arrangement with immediate effect and the Applicant shall be appointed as supervisor of the relevant individual voluntary arrangement in place of the Respondent with immediate effect.
7. The Applicant shall pursuant to Insolvency Rule 12.38(6) deliver notice of this Order to the creditors, in each of the insolvency proceedings set out in the Schedules hereto at the first reasonable opportunity to do so and in any event within 28 days of the date of this Order, by placing a block advertisement in the London Gazette.
8. There be liberty to each creditor to apply to vary or discharge this Order, insofar as it relates to the estate of which they are a creditor, within 28 days of the date of advertisement in accordance with paragraph 5 above. Such application shall not affect the transfer of the block transfer cases until further or other order by the court.

9. The Applicant shall file a copy of this order with each of the courts listed in the Schedule.
10. The Respondent shall have his release and be discharged from liability as office holder in respect of all the appointments in the Schedules hereto 28 days after the relevant notice referred to in paragraph 7 above has been advertised save that such release may be subject to further order in the event of an application by any creditor under paragraph 8 of this order for the specific case subject to that application.
11. Following the Orders made in paragraphs 1 to 10 above, the proceedings referred to in the Schedule be transferred back to the respective County Courts, as the case may be.
12. Pursuant to Rule 12.38 of the Insolvency (England & Wales) Rules 2016, the costs of this application be apportioned equally and payable as an expense of the insolvency proceedings to which the application relates save that where such apportioned costs would exceed 10% of the value of the realised assets in such proceedings those costs shall be apportioned equally and payable as an expense of the remaining insolvency proceedings.
