**1 Statutory information**

Intuitive Computer Management Ltd is a private company, limited by shares, registered in England and Wales, registration number 06878599. The registered office is Unit K10, Cradley Enterprise Centre, Maypole Fields, Cradley, B63 2QB.

**2 Directors' advances, credit and guarantees**

The balance owed from the directors at the year end was £5,396 (2020: £0). There were no conditions attached to the loan which was interest free.

**3 Average number of employees**

During the year the average number of employees was 7 (2020: 7).

For the year ending 30 April 2021 the company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies. The members have not required the company to obtain an audit in accordance with section 476 of the Companies Act 2006.
