7 Ultimate controlling party

The company is a wholly owned subsidiary of IWG Group Holdings S.A.R.L, (formerly known as Umbrella Holdings S.A.R.L.) a company incorporated and registered in Luxembourg.

The largest group in which the results of the Company are consolidated is that headed by IWG plc, a company incorporated in Jersey. The smallest group in which they are consolidated is that headed by Regus plc incorporated in Jersey and registered and domiciled in Luxembourg.
