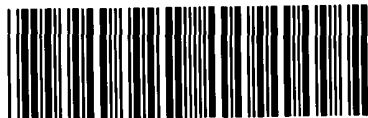



1 Accounting policies

Company information

Castle Galleries Retail Limited is a limited company domiciled and incorporated in England and Wales. The registered office is Unit 15 Spitfire Road, Erdington, Birmingham, West Midlands, England, B24 9PR.

Accounting convention

The financial statements have been prepared under the historical cost convention.

The financial statements have been prepared in sterling, which is the functional currency of the company. Monetary amounts in these financial statements are rounded to the nearest £.

These financial statements have been prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" ("FRS 102") and the requirements of the Companies Act 2006.

These financial statements for the year ended 30 April 2017 are the first financial statements of Castle Galleries Retail Limited prepared in accordance with FRS 102, The Financial Reporting Standard applicable in the UK and Republic of Ireland. The date of transition to FRS 102 was 1 May 2015.

The company has taken advantage of paragraph 35.10(m) of FRS 102 to retain its accounting policies for reported assets, liabilities and equity at the date of transition to this FRS until there is any change to those balances or the company undertakes any new transactions.

2 Controlling party

The ultimate parent company and controlling party is Halcyon Fine Art Group Holdings Limited, a company incorporated in England.
