- 7 THAT, subject to Resolution 1 having been passed, in accordance with section 570 of the Act, the directors be and they are hereby empowered to allot equity securities (within the meaning of section 560 of the Act) pursuant to the authority conferred by article 24 of the New Articles as if section 561 of the Act did not apply to any such allotment provided that this power
 - shall be limited to equity securities up to an aggregate nominal amount of £50, (a) and
 - (b) shall expire on 31 March 2010, save that the Company may before such expiry make an offer or agreement which would or might require equity securities to be allotted after such expiry and the directors may allot equity securities in

pursuance of any such offer or agreement as if the power conferred hereby had not expired
