MEMORANDUM OF ASSOCIATION

OF

CHANCERY TRUST LIMITED

1. The name of the company (hereinafter called "the Association") is CHANCERY TRUST LIMITED
2. The Registered Office of the Association is to be situated in England and Wales.

1.The objects for which the Association is established are:

3AObjects:-

- 1) The provision of financial and other support including such financial support as is envisaged by section 194 of the Legal Services Act 2007 as amended or re-enacted from time to time) to persons who provide, or organize or facilitate the provision of legal advice or assistance (by way of representation or otherwise) which is free of charge (that is, otherwise than for or in expectation of fee, gain or reward) and which is provided directly or indirectly to people who are in need of such advice or assistance by reason of youth, age, ill health, disability, financial hardship or other disadvantage, and
- 2) the promotion of such other purposes aimed at improving access to justice as being exclusively charitable according to the law of England and Wales the Management Committee may from time to time determine.

3B. **Powers;-**

Furtherance of the objects but not otherwise the Management Committee may Exercise the following powers:-

To raise funds and to invite and receive contributions provided that in the raising funds the Management Committee shall not undertake any substantial permanent trading activities and shall conform to any relevant requirements of the law.

And the association shall have the following additional powers exercisable in furtherance of its said objects but not otherwise, namely:-

(A) To purchase, take on lease or in exchange, hire or otherwise acquire real or personal property and rights and privileges, and to construct, maintain and alter buildings or erections

(B) To sell, let, mortgage, dispose of or turn to account all or any of the property or assets of the Association.

(C) To undertake and execute any charitable trusts which may lawfully be undertaken by the Association

(D) To borrow or raise money on such terms and on such security as may be thought fit

(E) To invest the moneys of the Association not immediately required for its purposes in or upon such investments, securities or property as may be thought fit, subject nevertheless to such conditions (if any) and such consents (if any) as may for the time being be imposed or required by law and subject also as hereinafter provided.

(F) To establish and support or aid in the establishment and support of any charitable associations or institutions and to subscribe or guarantee money for charitable purposes and commission the search as required.

(G) To do all such other things as are identical to the attainment or furtherance of the said objects or any of them.

Provided that:-

(1) In case the Association shall take or hold any property which may be subject to any trusts, the Association shall only deal with or invest the same in such manner as allowed by law, having regard to such trusts.

(2) The Association's objects shall not extend to the regulation of relations between workers and employers or organisations of workers and the organisations of employers.

(3) In case the Association shall take or hold any property subject to the jurisdiction of the Charity Commissions for England and Wales, the Association shall not sell, mortgage, charge or lease the same without such authority, approval or consent as may be required by law, and as regards any such property the Council of Management or Governing Body of the Association shall be chargeable for any such property that may come into their hands and shall be answerable and accountable for their own acts, receipts, neglects and defaults, and for the due administration of such property in the same manner and to the same extent as they would as such Council of Management or Governing Body have been if no incorporation had been effected, and the incorporation of the Association shall not diminish or impair any control or authority exerciseable by the Charity Commission over such Council of Management or Governing Body, but they shall as regards any such property be subject jointly and separately to such control or authority as if the Association were not incorporated.

4. The income and property of the Association shall be applied solely towards the promotion of its said objects as set forth in this memorandum of association and no portion thereof shall be paid or transferred directly or indirectly by way of dividend, bonus or otherwise howsoever by way of profit, to members of the Association and no member of its Council of Management or Governing Body shall be appointed to any office of the Association paid by salary or fees, or receive any remuneration or other benefit in money or money's worth from the Association.

Provided that nothing herein shall prevent any payment in good faith by the Association-

(A) of reasonable and proper remuneration to any member, officer or servant of the Association (not being a member of its Council of Management or Governing Body) for any services rendered to the Association;

(B) of interest at a rate not exceeding 6 per cent. per annum on money lent or reasonable and proper rent for premises demised or let by any member of the Association or of its Council of Management or Governing Body;

(C) To any member of its Council of Management or Governing Body of out-of-pocket expenses;

(D) to a company of which a member of the Association or of its Council of Management or Governing Body may be a member holding not more than one hundredth part of the capital of such company.

5. No addition, alteration, or amendment shall be made to or in the provisions of the Memorandum and Articles of Association for the time being in force, which would have the effect that the Association shall cease to be a company to which section 30 of the Companies Acts 1985 applies

6. The liability of members is limited
7. Every member of the Association undertakes to contribute such amount as may be required (not exceeding £1.00) to the assets of the Association if it should be wound up while he is a member or within the one year after he ceases to be a member, for payment of the Association's debts and liabilities contracted before he ceases to be a member, and of the costs, charges and expenses or winding up, and for the adjustment of the rights of the contributories among themselves.

We, the subscribers to the Memorandum of Association, wish to be formed into a company pursuant to this Memorandum

ARTICLES OF ASSOCIATION

OF

CHANCERY TRUST LIMITED

GENERAL

1. In these presents the words in the first column of the Table next hereinafter contained shall bear the meaning set opposite to them respectively in the second column thereof, if not inconsistent with the subject or context:-

Subject to the aforesaid, any words or expressions defined in the Act shall, if not inconsistent with the subject or context, bear the same meanings in the Articles.

2. The Association is established for the purposes expressed in the Memorandum of the Association.
3. The Subscribers to the Memorandum of Association and such other persons as the Council shall admit to the Membership in accordance with the Articles shall be Members of the Association. No person shall be admitted as a Member of the Association unless he is approved by the Council. Every person who wishes to become a member shall deliver to the Association an application for Membership in such form as the Council require executed by him.
4. A member may at any time withdraw from the Association by giving at least seven clear days' notice to the Association. Membership is not transferable and shall cease on death.

GENERAL MEETINGS

5. Unless the Association has elected by Elective Resolution to dispense with the holding of an Annual General Meetings the Association shall hold a General Meeting in every calendar year as its Annual General Meeting at such time and in such place as may be determined by the Council, and shall

specify the Meeting as such in the notices calling it, provided that every Annual General Meeting except the first shall be held not more than fifteen months after the holding of the last preceding Annual General Meeting, and that so long as the Association holds its first Annual General Meeting within eighteen months after its incorporation it need not hold it in the year of its incorporation or in the following year.

6. All General Meetings, other than Annual General Meetings shall be called Extraordinary General Meetings.
7. The Council may whenever they think fit convene an Extraordinary General Meeting, and Extraordinary General Meetings shall also be convened on such requisition, or in default, may be convened by such requisitionists, as provided by section 368 of the Act
8. Twenty-one clear days' notice in writing at the least of every Annual General Meeting and of every Meeting convened to pass a Special Resolution or an Elective Resolution, and fourteen clear days' notice in writing at least of every other General Meeting, specifying the place, the day and the hour of the meeting, and in the case of special business the general nature of that business, shall be given in manner hereinafter mentioned to such persons (including the Auditors) as are under these Articles or under the Act entitled to receive such notices from the Association; but with the consent of all the members having the right to attend and vote thereat, or of such proportion of them as is prescribed by the Act in the case of meetings other than Annual General Meetings, a meeting may be convened by such notices as those members may think fit.
9. The accidental omission to give notice of a Meeting to, or the non-receipt of such notice by, any person entitled to receive notice thereof shall not invalidate any resolution passed, or proceeding had, at any Meeting.

PROCEEDINGS AT GENERAL MEETINGS

10. All business shall be deemed special that is transacted at an Extraordinary General Meeting, and all that is transacted at an Annual General Meeting shall also be deemed special, with the exception of the consideration of the income and expenditure account and balance sheet, and the reports of the Council and of the Auditors, the election of Members of the Council in the place of those retiring, and the appointment of, and the fixing of the remuneration of, the Auditors.
11. No business shall be transacted at any General Meeting unless the quorum is present when the meeting proceeds to business. Save as herein otherwise provided three Members or one tenth of the total number of Members whichever number is the greater personally present shall be a quorum.
12. If within half an hour from the time appointed for the holding of a General Meeting a Quorum is not present, the meeting, if convened on the

requisition of members, shall be dissolved. In any other case it shall stand adjourned to the same day in the next week, at the same time and same place, or at such other place as the Council may determine.

13. The Chairman (if any) of the Council shall preside as Chairman at every General Meeting, but if there be no such Chairman, or if at any Meeting he shall not be present within fifteen minutes after the time appointed for holding the same or shall be unwilling to preside, the Members present shall choose some other Member of the Council, or if no such Member be present, or if all the members of the Council present decline to take the chair, they shall choose a member of the Association who shall be present to preside.
14. The Chairman may, with the consent of any Meeting at which a quorum is present (and shall if so directed by the meeting) adjourn the Meeting from time to time, and from place to place, but no business shall be transacted at any adjourned meeting other than business which might have been transacted at the Meeting from which the adjournment took place.

Whenever a Meeting is adjourned for thirty days' or more, notice of the adjourned Meeting shall be given in the same manner as of an original Meeting. Save as aforesaid, the Members shall not be entitled to any notice of an adjournment, or of the business transacted at an adjourned meeting

15. At any General Meeting a resolution put to the vote of the meeting shall be decided on a show of hands, unless a poll is before or upon the declaration of the result of the show of hands, demanded by the Chairman or by at least two Members present in person or by proxy, or by a Member or Members present in person or by proxy and representing one-tenth of the total voting rights of all the Members having the right to vote at the Meeting, and unless a poll be so demanded a declaration by the Chairman of the meeting that a resolution has been carried, or carried unanimously or by a particular majority, or lost, or not carried by a particular majority, and an entry to that effect in the minute book of the Association shall be conclusive evidence of the fact without proof of the number or proportion of the votes recorded in favour of or against that resolution. The demand for a poll may be withdrawn.
16. Subject to the provisions of the Article 17, if a poll be demanded in manner aforesaid, it shall be taken at such a time and place and in such manner, as the Chairman of the Meeting shall be direct, and the result of the poll shall be deemed to be the resolution of the Meeting at which the poll was demanded.
17. No poll shall be demanded on the election of a Chairman of a Meeting, or on any question of adjournment.
18. In the case of an equality of votes, whether on a show of hands or on a poll, the Chairman of the meeting shall be entitled to a second casting vote.
19. The demand of a poll shall not prevent the continuance of a

Meeting for the transaction of any business other than the question on which a poll has been demanded.

20. Subject to the provisions of the Act a resolution in writing signed by all the Members for the time being entitled to receive notice of and to attend and vote at General Meeting (or being corporations by their duly authorised representatives) shall be as valid and effective as if the same had been passed at a General Meeting of the Association duly convened and held.

VOTES OF MEMBERS

21. Subject as hereinafter provided, every Member shall have one vote.
22. Save as herein expressly provided, no Member other than a Member duly registered, who shall have paid every subscription and other sum (if any) which shall be due and payable to the Association in respect of his membership, shall be entitled to vote on any question either personally or by proxy, or as a proxy for another Member at any General Meeting.
23. No objection shall be raised to the qualification of any voter except at the Meeting or adjourned meeting at which the vote objected to is tendered, and every vote not disallowed at the Meeting shall be valid. Any objection made in due time shall be referred to the Chairman of the Meeting whose decision shall be final and conclusive.
24. Votes may be given on a poll either personally or by proxy. On a show of hands a Member present only by proxy shall have no vote, but a proxy for a corporation may vote on a show of hands. A corporation may vote by its duly authorised representative appointed as provided by section 375 of the Act. A proxy need not be a Member.
25. The instrument appointing a proxy shall be in writing under the hand of the appointor or his attorney duly authorised in writing, or if such appointor is a corporation under its common seal, if any, and, if none, then under the hand of some officer duly authorised in that behalf.
26. The instrument appointing a proxy and the power of attorney or other authority (if any) under which it is signed or a notarially certified or office copy thereof shall be deposited at the office not less than forty-eight hours before the time appointed for holding the Meeting or adjourned Meeting at which the person named in the instrument proposes to vote, or in the case of a poll not less than twenty-four hours before the time appointed for the taking of the poll, and in default the instrument of proxy shall not be treated as valid. No instrument appointing a proxy shall be valid after the expiration of twelve months from the date of its execution.
27. A vote given in accordance with the terms of an instrument of proxy shall be valid notwithstanding the previous death or insanity of the principal or revocation of proxy or of the authority under which the proxy was executed,

provided that no imitation in writing of the death, insanity or revocation as aforesaid shall have been received at the office before the commencement of the Meeting or adjourned Meeting at which the proxy is used.

28. Any instrument appointing a proxy shall be in the following form or as near thereto as circumstances will admit:-

The instrument appointing a proxy shall be deemed to confer authority to demand or join in demanding a poll.

COUNCIL OF MANAGEMENT

29. Until otherwise determined by a General Meeting, the number of the members of the Council shall be not less than three nor more than seven.
30. The first members of the Council shall be as named in the statement delivered to the Registrar of Companies pursuant to section 10 of the Act.
31. The Council may from time to time and at any time appoint any Member of the Association as a Member of the Council , either to fill a casual vacancy or by way of addition to the Council, provided that the prescribed maximum be not thereby exceeded. Any Member so appointed shall retain his office until the next Annual General Meeting, but he shall then be eligible for re-election.
32. No person who is not a Member of the Association shall in any circumstances be eligible to hold office as a Member of the Council.

POWER OF THE COUNCIL

33. The business of the Association shall be managed by the Council who may pay all such expenses of, and preliminary and incidental to, the promotion, formation, establishment and registration of the Association as they think fit, and may exercise all such powers of the Association, and do on behalf of the Association all such acts as may be exercised and done by the Association, and as are not by the Act or by the Articles required to be exercised or done

by the Association in General Meeting, subject nevertheless to any regulations of the Articles, to the provisions of the Act and to such regulations, being not inconsistent with the aforesaid regulations or provisions, as may be prescribed by the Association in General Meeting: but no regulation made by the Association in General Meeting shall invalidate any prior act of the Council which would have been valid if such a regulation had not been made.

34. The members for the time being of the Council may act notwithstanding any vacancy in their body; provided always that in case the Members of the Council shall at any time be reduced in number to less than the minimum number prescribed by or in accordance with these Articles, it shall be lawful for them to act as the Council for the purpose of admitting persons to the Membership of the Association, filling up vacancies in their body, or of summoning a General Meeting, but not for any other purpose.

SECRETARY

35. Subject to the provisions of the Act the Secretary shall be appointed by the Council for such time at such remuneration and upon such conditions as they may think fit, and any secretary so appointed may be removed by them. The provisions of sections 283 and 284 of the Act shall apply and be observed. The Council may from time to time by resolution appoint an assistant or Deputy Secretary, and any person so appointed may act in place of the Secretary if there be no Secretary capable of acting.

THE COMMON SEAL

36. The Association's common seal shall not be affixed to any instrument except by the authority of a resolution by the Council, and in the presence of at least two Members of the Council and of the Secretary, and the said Members and Secretary shall sign every instrument to which the common seal shall be affixed to in the presence, and in favour of any purchaser or person bona fide dealing with the Association such signatures shall be conclusive evidence of the fact that the common seal has been properly affixed.

DISQUALIFICATION OF MEMBERS OF THE COUNCIL

37. The office of a Member of the Council shall be vacated:-
- (a) If he becomes bankrupt or makes any arrangement or composition with his creditors generally
 - (b) If he becomes of unsound mind
 - (c) If he ceases to be a Member of the Association
 - (d) If he ceases to hold office by virtue of any provision of the Act or he

becomes prohibited by law from being a Director of a Company.

ROTATION OF THE MEMBERS OF THE COUNCIL

38. At the first Annual General Meeting and at any Annual General Meeting to be held in any subsequent year, one-third of the Members of the Council for the time being, or if their number is not a multiple of three then the number nearest to one-third, shall retire from office.
39. The Members of the Council to retire shall be those who have been longest in office since their last election or appointment. As between Members of equal seniority, the Members to retire shall in the absence of agreement be selected from among them by lot. The length of time a Member has been in office shall be computed from his last election or appointment. A retiring Member of the council shall be eligible for re-election.
40. The Association may, at the Meeting at which the member of the Council retires in manner aforesaid, fill up the vacated office by electing a person thereto, and in default the retiring Member shall, if offering himself for re-election, be deemed to have been re-elected, unless at such meeting it is expressly resolved not to fill up such vacated office, or unless a resolution for the re-election of such Member shall have been put to the Meeting and lost.
41. No person not being a Member of the Council retiring at the Meeting shall, unless recommended by the Council for election, not be eligible for election to Membership of the Council at any General Meeting, unless, within the prescribed time before the day appointed for the Meeting there shall have been given to the Secretary notice in writing, by some Member duly qualified to be present and vote at the Meeting for which such notice is given, of his intention to propose such person for election, and also notice in writing, signed by the person to be proposed, of his willingness to be elected. The prescribed time above mentioned shall be that, between the date when the notice is served, or deemed to be served, and the day appointed for the Meeting there shall be not less than four nor more than twenty-eight intervening days'.
42. The Association may from time to time in General Meeting increase or reduce the number of Members of Council, and determine in what rotation such increased or reduced number shall go out of office, and may make the appointments necessary for effecting any such increase.
43. In addition and without prejudice to the provisions of section 303 of the Act, the Association may by Extraordinary Resolution remove any Member of the Council before the expiration of his period of office, and may by an ordinary Resolution appoint another qualified Member in his stead; but any person so appointed shall retain his office so long only as the Member in whose place he is appointed would have held the same if he had not been removed.

PROCEEDINGS OF THE COUNCIL

44. The Council may meet together for the dispatch of business, adjourn and otherwise regulate their meetings as they think fit, and determine the quorum necessary for transaction of business. Unless otherwise determined, three shall be the a quorum. Questions arising at any meeting shall be decided by a majority of votes. In case of an equality of votes the Chairman shall have a second casting vote.
45. A member of the Council may, and on the request of a Member of Council the Secretary shall, at any time, summon a meeting of the Council by notice served upon the several Members of the Council. A Member of the Council who is absent from the United Kingdom shall not be entitled to notice of a Meeting.
46. The Council shall from time to time elect a Chairman who shall be entitled to preside at all Meetings of the Council at which he shall be present, and may determine for what period he is to hold office, but if no such Chairman be elected, or if at any meeting the Chairman be not present within five minutes after the time appointed for holding the meeting and willing to preside, the members of the Council present shall choose one of their number to be Chairman of the Meeting.
47. A meeting of the Council at which a quorum is present shall be competent to exercise all the authorities, powers and discretions by or under the regulations of the Association for the time being vested in the Council generally.
48. The Council may delegate any of their powers to committees consisting of such member or members of the Council as they think fit, and any committee so formed, shall in the exercise of the powers delegated, conform to any regulations imposed on it by the Council. The meeting and proceedings of any such committee shall be governed by the provisions of the Articles for regulating the meetings and proceedings of the council so far as applicable and so far as the same shall not be superseded by any regulations made by the Council.
49. All acts bona fide done by any meeting of the Council or of any committee of the Council, or by any person acting as a member of the Council shall notwithstanding it to be afterwards discovered that there was some defect in the appointment or continuance on office of any such member or person acting as aforesaid, or that they or any of them were disqualified, be as valid as if every person had been duly appointed or had duly continued in office and was qualified to be a Member of the Council.
50. The Council shall cause proper records to be kept of all Written Resolutions (and of the signatures). The Council shall cause proper minutes to be made of all appointments of officers made by the Council and of the proceedings

of all meetings of the Association and of the Council and of Committees of the Council, and all business transacted at such meetings. All such records (and signatures) and minutes shall be entered in books provided for the purpose. Any such record purporting to be signed by a Director or by the Secretary shall be evidence of the proceedings in agreeing to the Written Resolution and until the contrary is proved the requirements of the Act with respect to those proceedings shall be deemed to be complied with. Any such minutes of any meeting, if purporting to be signed by the Chairman of such Meeting, or by the Chairman of the next succeeding meeting, shall be sufficient evidence without and further proof of the facts therein stated.

51. A resolution in writing signed by all the members for the time being of the Council or any such committee of the Council who are entitled to receive notice of a meeting of the Council or of such committee shall be as valid and effectual as if it has been passed at a meeting of the Council or of such committee duly convened and constituted.

ACCOUNTS

52. The Council shall cause accounting records to be kept in accordance with the requirements of the Act.
53. The accounting records shall be kept at the office, or, subject to the provisions of the Act, at such other place or places as the Council shall think fit, and shall always be open to the inspection of the Officers of the Association.
54. The Council shall from time to time in accordance with the provisions of the Act cause to be prepared such income and expenditure accounts, balance sheets and reports as are required by the Act. The Council shall send a copy of the annual accounts together with a copy of the Council's report for that financial year and a copy of the Auditors' report on those accounts to the Auditor and to every person entitled to receive the same in accordance with section 238 of the Act not less than 21 days' before the date of the Meeting at which those documents are to be laid in accordance with section 241 of the Act, or, where there is in force an election by Elective Resolution to dispense with the laying of accounts and report, not less than 28 days' before the end of the period allowed for laying and delivering the same.
55. The Council shall from time to time determine whether and to what extent and at what times and places and under what conditions or regulations accounting records of the Association or any of them shall be open to the inspection of Members not being officers of the Association, and no Member (not being an officer) shall have any right of inspecting any accounting records or other book or document of the Association except as conferred by statute or authorised by the Council or by the Association in General Meeting.

AUDIT

56. In accordance with the provisions of the Act once at least every year the accounts of the Association shall be examined and the correctness of the income and expenditure account balance sheet ascertained by an independent person or persons who is and are not members of the Association or by a properly qualified Auditor or Auditors.
57. If Auditors shall be appointed and their duties must be regulated in accordance with the provisions of the Act, the Members of the Council being treated for all purposes as the Directors mentioned in those provisions.

NOTICES

58. A notice may be served by the Association upon any Member, either personally or by sending it through the post in a prepaid letter, addressed to such Member at his registered address as appearing in the register of Members.
59. Any Member described in the register of Members by an address not within the United Kingdom, who shall from time to time give the Association an address within the United Kingdom at which notices may be served upon him, shall be entitled to have notices served upon him at such address, but, save aforesaid and as provided by the Act, only those Members who are described in the register of Members by an address within the United Kingdom shall be entitled to receive notices from the Association.
60. Any notice, if served by post, shall be deemed to have been served on the day following that on which the letter containing the same is put into the post, and in proving such service it shall be sufficient to prove that the letter containing the notice was properly addressed and put into the post office as a prepaid first class letter.

DISSOLUTION.

61. If upon winding up or dissolution of the Association there remains, after the satisfaction of all its debts and liabilities, any property whatsoever, the same shall not be paid to or distributed among the Members of the Association, but shall be transferred either to some other institution (whether or not a Member of the Association) having objects similar to the objects of the Association, or some institution (whether or not a Member of the Association) the objects of which are the promotion of charity and anything incidental or conducive thereto, such institution or institutions to be determined by the members of the Association at or before the time of dissolution.
