1. ACCOUNTING POLICIES

1.1 Basis of preparation of financial statements

The full financial statements, from which these abbreviated accounts have been extracted, have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008)

1.2 Going concern

At the balance sheet date the company had a shareholders' deficit of £36,991. Included in creditors is £21,079 due to the director. The director has confirmed he will not withdraw these loans to the detriment of the company and therefore the accounts have been prepared on a going concern basis

1.3 Turnover
