TRUSTEES' REPORT INCORPORATING STRATEGIC REPORT

The Trustees of the University of Chester Academies Trust, who are also directors of the Trust for the purposes of the Companies Act, present their statutory report and the audited financial statements for the year ended 31 August 2015.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Constitution and Principal Activities

The Trust is a company limited by guarantee (Company registration number 06929486) and an exempt charity. The charitable company's Memorandum and Articles of Association are the primary governing documents of the Academy and were set up in November 2011 as amended in September 2014. All of the trustees are also directors of the limited company for the purposes of company law. The Trust operates 5 secondary academies, 2 primary academies and a free school in the North West of England. Its academies have a combined pupil capacity of 4,980 and had a roll of 3,490 in the October 2014 school census.

Members of the Trust are nominated by either the Secretary of State for the Department of Education or the principal sponsor the University of Chester. The company's Articles of Association set out the categories of Director of the Company and the process for their appointment.

The 'funding agreement' was executed and delivered as a deed in November 2011, amended in line with the latest DfE model on 28th October 2014 and signed by the Trust and the Secretary of State for Education. The funding agreement specifies the roles and responsibilities of each of the Trust and the Secretary of State in developing and maintaining academies within the Trust. There are also the Supplementary Funding Agreements in relation to each Academy.

The principal object and activity of the charitable company is more specifically the sponsorship, establishment, maintenance and development of a number of Academies and Free schools to provide education for students of different abilities between the ages of 4 and 18, offering a broad and balanced curriculum.

Members' liability

Each member of the charitable company undertakes to contribute to the assets of the company in the event of it being wound up while he/she is a member, or within one year after he/she ceases to be a member, such amount as may be required, not exceeding £10, for the debts and liabilities contracted before he/she ceases to be a member.

Governance

Trustees are directors of the charitable company for the purposes of the company law and Trustees for the purposes of charity legislation, and are also Governors of the Academy Trust. Details of the Trustees and Directors who served during the year ended 31 August 2015, are included in the Reference and Administration Details on Page 3.

All of the Trustees and Directors are appointed in accordance with the process for appointment within the Articles of Association. The Articles of Association of the Trust were amended in September 2014 and any new appointments of Directors will follow the requirements of the new Articles.

The Directors operating as the Trust Board have developed a detailed scheme of Delegation which assigns responsibility for decision making across the Trusts activities. During the year to 31 August 2015, this specifically included delegation to Statement of Action Committees at each academy.

Following the issue of a pre-warning notice from the Department for Education in 2013 the Trust was required to take action to tighten lines of accountability and therefore its governance arrangements are subject to regular formal review and revision to ensure that they are fit for purpose. Governance arrangements were reviewed in January 2015.

A programme of induction for new Directors and Governors of individual Academies is under development. However, Statement of Action Committees are chaired by National Leaders of Governance to ensure current knowledge and expertise.

In accordance with normal commercial practice and the specific enabling provisions within its Articles of Association, the Trust is purchasing insurance to protect trustees, directors and relevant officers from claims arising from negligent acts, errors or omissions occurring whilst on Academy business.

Organisational structure

The existing Lines of Delegation continues to be regularly reviewed. This details the organisational structure for the Board of Trustees/Directors through a main Board and a separate Audit and Scrutiny Committee. Statement of Action Committees, who effectively operate as Local Governing Bodies, hold Academy Principals to account and report regularly to the Board. The Chief Executive Officer (who is the Accounting Officer) and other key officers within the central UCAT senior leadership team are responsible for day to day operations. In reality, this means that the UCAT Board determines UCAT wide policy and budgets, the Board and its committees monitor the implementation and the Statement of Action Committees make any local variations to policy and hold the Principal to account along with the UCAT Senior Leadership Team, which operates centrally across the Academy Trust.

Risk Management

The Board of Directors reviewed the process for managing risk and agreed that it would be managed at Board level. This involved focussing on the most significant risks to the organisation; putting systems and processes in place to mitigate these risks; and the Board monitoring the impact of actions on mitigating risks.

Connected Organisations

The sponsor of UCAT is the University of Chester via the University of Chester Trust (UCT) and a formal Memorandum of Agreement sets out the terms of this relationship.

UCAT was the lead sponsor for the University Academy Birkenhead (UAB), the responsibility having been delegated from UAB's lead sponsor the University of Chester. During the course of the year the University of Chester formally withdrew from its sponsorship role at UAB effective from 17/03/2015.

Objectives and Activities

The principal object and activity of the charitable company is more specifically the sponsorship, establishment, maintenance and development of a number of Academies and Free Schools to provide education for students of different abilities between the ages of 4 and 18, offering a broad and balanced curriculum.

The main objective of the Trust during the year ending 31 August 2015 was to enhance the educational experience and attainment of all students at UCAT Academies.

Strategies and Activities

The Trust's strategy for improvement is underpinned by its vision for our pupils and staff that is captured in our motto: *Believe, Belong, Become*. Therefore in each of its academies UCAT's aim is to develop and maintain a culture that:

- enables individuals to Believe in themselves and in their ability, as well as in others.
- cultivates within our pupils and staff a true sense that they Belong to a family that cares for them
 and supports them.
- enriches and extends their learning so that each can Become the individual they aspire to be.

This aim will be achieved by working together – in and across academies – drawing on the expertise within its family of schools; having learning at the heart of everything it does; and maximising on the learning opportunities available for all. The focus for individuals is on improving their own practice; for teams on supporting the development and professional growth of each other; and for academies on looking at ways of supporting each other to improve and grow into outstanding organisations so that UCAT pupil outcomes are the very best they can be. Leaders, teachers, support staff, pupils, parents and governors working consistently and coherently together to improve the quality of teaching and learning have the potential to build a Trust where every pupil will experience outstanding teachers and every academy will have outstanding leaders.

Equal Opportunities

UCAT complies with all relevant legislation, including the Equalities Act 2010, which covers disabled persons amongst other protected characteristics. The Trust is fully committed to the need to have due regard to its Public Sector Equality Duty in all of its planning, policy making and decision making. It has ensured that, at all key meetings of the Board, Statement of Action Committees and Senior Leadership Meetings, all matters under discussion will take equality considerations into account. Furthermore, in 2012 our Equality aims for 2012 – 2016 were published as follows and UCAT continues to make progress with them:

Objective 1 - Aim: By 2016 all Governing Body Members and employees will receive adequate training in Equality and Diversity.

Expected Outcome: Will increase staff understanding of equality and its implications on a day-to-day basis, and in this way to reduce or remove inequalities in attainment throughout the school, particularly inequalities relating to the protected characteristics listed in the Equality Act 2010.

Objective 2 - Aim: By 2016 to have taken positive steps to encourage applications for staff posts from people reflective of the diversity of the students and the communities from which they draw.

Expected Outcome: An increasingly diverse leadership team drawn from across the Trust.

Objective 3 - Aim: Narrow the gap between boys and girls in terms of expected progress and achievement in English and Maths.

Expected Outcome: From 2013 in each of our academies the gap narrows in terms of expected progress made by boys and girls to be less than the national average.

Objective 4 - Aim: Foster good relations and understanding between different communities of students within our academies.

Expected Outcome: By 2014 we can evidence a decrease in the number of reported incidents of bullying and racial discrimination by reference to the appropriate academy records.

Objective 5 - Aim: Ensure that Pupil Premium is a key contribution to raising achievement for disadvantaged students.

Expected Outcome: By 2015 we can evidence appropriate use of Pupil Premium in all academies.

Employee Consultation

The Trust encourages the involvement of its employees in its management through regular meetings of Trade Unions, underpinned by a Trade Union Recognition Agreement. This group is a vehicle for the dissemination of information of particular concern to employees (including financial and economic factors affecting the performance of the Academy and for receiving their views on important matters of policy. The model is replicated at academy level to deal with local matters

Public Benefit

The Directors have complied with their duty to have due regard to the guidance on public benefit published by the Charity Commission in exercising their powers and duties.

In setting the objectives and planning their activities the Directors, as Trustees, gave careful consideration to the Charity Commission's general guidance on public benefit. The Trust exists to transform young lives through the power of education and the Trustees are committed to doing this by providing the best educational opportunities for their students so they may lead happy and fulfilling lives with high aspirations for their future.

The main objective of the Trust during the year ending 31 August 2015 was to enhance the educational experience and attainment of all students at UCAT Academies. The Directors continued to respond following the issue of a pre-warning notice from the Department for Education by developing and implementing a school improvement strategy in close liaison with a strategic partner to support the drive for improvement and further pursue their commitment to provide the best educational opportunities to the students of its academies.

STRATEGIC REPORT

Review of Achievements and Performance for the Year

Background:

By September 2014 UCAT had been in operation since September 2009 and had 8 schools in its multiacademy trust – 5 secondary, 2 primary and 1 free school. In addition to these there was also one further secondary in a co-sponsor arrangement. Of those 3 were in special measures and 5 had not had its first inspection.

A strategy for recovery was agreed by The UCAT Trustree Board with:

Stage 1: laying the foundations - systems, structures and processes

Stage 2: building capacity

Stage 3: refining and establishing

Stage 1 was implemented during 2014 – 2015. There were five strands to the implementation plan:

- 1. Restructuring Governance arrangements
- 2. Redefining the UCAT Portfolio
- 3. Restructuring of support services
- 4. Implementing a school improvement programme
- 5. Strengthening links with the University of Chester

1. Restructuring governance arrangements

Governance arrangements for UCAT were put in place to align with its new Articles of Association. A new Board of Directors was set up and a new Chair appointed who brought current expertise and experience of running an international company. The new Board structure provided both business and educational expertise to inform and challenge the way in which UCAT was operating as well as the plans for school improvement.

Statement of Action Committees (SOACs) were set up in each school to act as Interim Education Boards (IEBs) for the period of UCAT's recovery. The role of the SOAC is to monitor the progress the school is making; monitor use of resources; and challenge and support in terms of driving forward school improvement on behalf of the Board. These have been chaired by National Leaders of Governance (NLGs).

Community Development Groups have been set up in some schools to engage parents and the local community but they have no delegated powers.

2. Redefining the UCAT Portfolio

It had been agreed in June 2014 that University Academy Birkenhead (UAB) should move to another sponsor. In January 2015 the UCAT Board agreed that University Academy Liverpool (UAL) should leave the Trust. In addition it was agreed to close the 6th forms in UAK and UAW due to falling numbers with effect from September 2017.

3. Restructuring of support services

schools.

From January 2015 a restructuring of central team services began that led to a reduction in the number of staff working at the centre. HR Business Partners and Link Accountants – origionally part of the central team - were moved to being based in schools and working as part of the school team. In May 2015 UCAT moved its main office to UCEA and set up UCAT offices in each of its secondary

4. Implementing a school improvement programme

St John Plessington College, a Teaching School, were commissioned by UCAT to implement Stage 1 of the strategy - building on the School Improvement Programme they had put in place at UCEA. Their brief was to put in place the systems, structures and processes that would lay the foundations for school improvement in each of UCAT's secondary schools. The Principal of SJP took on the role of Executive Principal working across the four schools. This arrangement ended in August 2015 at the end of Stage 1 of the strategy (see exceptional costs on page 34).

5. Strengthening links with the University of Chester

Throughout the year there have been a number of activities in which the University has provided opportunities for pupils to engage with the University. Both within the university and within each academy. Discussions have been held as to how these arrangements can be further strengthened to provide a pathway from school to further education.

External examination results in summer 2015 were significantly affected by national changes in the arrangements and requirements for secondary examinations at the end of Key Stage 4. This raised the level of challenge for UCAT students and makes comparison with results from previous years difficult. However, one of the key indicators for secondary school performance (5 or more A*-C including English and Maths at GCSE) together with Key Stage 2 results for primaries is set out in the following tables.

Going Concern

After making appropriate enquiries, the Trustees have a reasonable expectation that the Academy Trust has adequate resources to continue in operational existence for the foreseeable future. For this reason it continues to adopt the going concern basis in preparing the financial statements. Further details regarding the adoption of the going concern basis can be found in the Statement of Accounting Policies.

Performance Indicators

The Trust is committed to observing the importance of performance indicators, to ensure that it continues to strive for both educational and financial excellence. The Trust is monitored through the completion and submission to the EFA of:

- Annual Accounts Return:
- Annual Budget Forecast; and
- Pupil Numbers (School census).

Financial Review

Most of the Trust's income is obtained from the DfE in the form of recurrent grants, the use of which is restricted to particular purposes. The grants received from the DfE during the year ended 31 August 2015 and the associated expenditure are shown as restricted funds in the Statement of Financial Activities.

The Trust also receives grants for fixed assets from the DfE. In accordance with the Charities Statement of Recommended Practice, 'Accounting and Reporting by Charities' (SORP 2005), such grants are shown in the Statement of Financial Activities as restricted income in the fixed asset fund. The restricted fixed asset fund balance is reduced by annual depreciation charges over the expected useful life of the assets concerned.

At 31 August 2015 the net book value of fixed assets was £45,879,000 and movements in tangible fixed assets are shown in note 11 to the financial statements. The assets were used exclusively for providing education and the associated support services to the students of the Academies within the Trust.

UCEA has a £100,000 Permanent Endowment from Cheshire West and Chester Council (the capital to remain untouched), with the interest arising available to be used for the benefit of the students.

Income in the year ended 31 August 2015 exceeded expenditure by £672,000 after taking into account exceptional income of, £2,500,000 relating to fixed assets donated by the EFA to the Trust for the University Cathedral Free School together with depreciation of fixed assets of £1,947,000 and exceptional costs of £1,117,000.

It should also be noted that actuarial gains on the defined benefit pension scheme of £313,000 have arisen in the year. Provision has been made in the financial statements under FRS 17 for the deficit identified in the actuarial valuation of the Local Government Defined Benefit Pension Schemes in which a number of support staff are members. Details of the provision are given in Note 19 to the financial statements. The only cash flow impact of this deficit is that the employers contribution rates for all schemes include a past service rate based on the 2013 valuation to clear the deficit over a 20 year period.

The Trustees have reviewed the fund balances carried forward at 31 August 2015, together with the projected results for 2015/16 and the following three years, and confirm that it is appropriate for the financial statements to be drawn up on the going concern basis.

Reserves policy

The Trustees have determined that they will hold sufficient free reserves (unrestricted funds) to be able to support individual academies at specific times during their development e.g. investing in infrastructure, funding costs associated with change management or supporting academies through changes in pupil numbers. These reserves will be held between 5-10% of general restricted and unrestricted income, the current level is £2,435,000 (9.4%) and there are plans to use some of these reserves to support school improvement as detailed under plans for future periods.

Investment Policy

The Trust has a risk-averse appetite to investments; any surplus reserves are invested for maximum return within that risk appetite.

Principal Risks and Uncertainties

The Trust has continued work during the year to develop and embed the system of internal control, including financial, operational and risk management, which is designed to protect the Academies' assets and reputation.

The Board of Directors reviewed the process for managing risk and agreed that it would be managed at Board level. This involved focussing on the most significant risks to the organisation; putting systems and processes in place to mitigate these risks; and the Board monitoring the impact of actions on mitigating risks using a consistent scoring system. Risks identified at academy level are managed through the Statement of Action prepared and monitored by the SOAC. These will be regularly reviewed by the Board.

Outlined below is a description of some of the risk factors that may affect the Trust. Not all the factors are within the Trust's control. Other factors besides those listed may also adversely affect the Trust.

1. Falling pupil numbers will impact on schools' viability

The majority of academies within the Trust, particularly secondaries, are not yet at capacity which affects funding.

The risk is mitigated in a number of ways:

- Curriculum led budget
- Communication and marketing strategy
- Considerable focus and investment on improving teaching which will, in turn, increase results and make UCAT academies more attractive to parents and students.

2. Not able to attract high quality teachers

Teacher recruitment is challenging for the majority of schools and competition for the best teachers is fierce.

The risk is mitigated in a number of ways:

- Define what UCAT expectations are in terms of teacher quality
- UCAT offer an attraction strategy
- Targeted marketing strategy

Plans for Future Periods

Next steps

In reviewing the progress made towards recovery in 2014 – 2015 and looking at the impact on Summer results in secondary it was proposed that UCAT should:

- ensure that the Stage 1 for school improvement: structures, systems and processes were effective and being applied consistently in each of UCAT's academies
- put in place Stage 2: building capacity by focussing on improving teaching and learning across UCAT - with strong emphasis on developing teachers' subject knowledge for teaching.

The UCAT Board considered appropriate targets for the academic year 2015/16 at the beginning of the autumn term.

Post Balance Sheet Event - University Academy Liverpool

Although the transfer to Great Schools Trust was due to take place as at 31st August 2015, a delay in completion of the legal documentation from the PFI lender meant that the transfer did not take effect until the 1st November 2015 (see Note 23).

Statement as to Disclosure of Information to Auditors

The Trustees have confirmed that, as far as they are aware, there is no relevant audit information of which the auditors are unaware. Each of the Trustees have confirmed that they have taken all the steps that they ought to have taken as Trustees in order to make themselves aware of any relevant audit information and to establish that it has been communicated to the auditor.

The financial statement auditors, RSM UK Audit LLP (formerly Baker Tilly UK Audit LLP), has indicated its willingness to continue in office.

GOVERNANCE STATEMENT

Scope of Responsibility

As trustees we acknowledge we have overall responsibility for ensuring that the Trust has an effective and appropriate system of control, financial and otherwise. However such a system is designed to manage rather than eliminate the risk of failure to achieve business objectives, and can provide only reasonable and not absolute assurance against material misstatement or loss.

The trustees have delegated the day-to-day responsibility during the year to the Managing Director, Prof. David Cracknell, as Accounting Officer and subsequently to Linda Rowe who became the Chief Executive Officer on 1 September 2015 who succeeded with these responsibilities for ensuring financial controls conform with the requirements of both propriety and good financial management and in accordance with the requirements and responsibilities assigned to it in the master funding agreement and supplementary funding agreements between UCEA, UCAN, UAK, UAK, UCFS, UPAK, UPAW and the Secretary of State for Education.

The Accounting Officer is also responsible for reporting to the trustees any material weaknesses or breakdowns in internal control.

Governance

Governance Review

In February 2015 the governance system was reviewed. From that date, Members met separately to steer reshaping and continuous improvement. The Board of Directors are answerable to Members for the operation of the Trust. The Education and Standards Committee was removed at this point and the Board took over these responsibilities.

GOVERNANCE STATEMENT

Review of Value for Money

As accounting officer the chief executive has responsibility for ensuring that the academy trust delivers good value in the use of public resources. The accounting officer understands that value for money refers to the educational and wider societal outcomes achieved in return for the taxpayer resources received.

The accounting officer considers how the trust's use of its resources has provided good value for money during each academic year, and reports to the board of trustees where value for money can be improved, including the use of benchmarking data where available. The accounting officer for the academy trust has delivered improved value for money during the year by:

In September 2014 the Trust was still under a Pre-warning notice issued by the DfE in April 2013. A proposal had been agreed by the UCAT Board for a UCAT wide recovery programme that had the first stage focussed on laying the foundations for improvement – the systems, structures and processes. With no outstanding school within its family UCAT commissioned St. John Plessington College (SJP) to put in place the systems, structures and processes for school improvement in four of UCAT's secondary academies. This work built on the school improvement programme that had started in place at UCEA in 2013 – 2014. The Principal of SJP took on the role of Executive Principal working across the four schools to drive school improvement. It was an improvement model that was heavily dependent on SJP staff taking key roles in UCAT schools. This intensive model was needed as they were endeavouring to shift ways of working in schools that for the most part had been of poor quality for a considerable period of time. In 2014 – 2015 they laid the foundations across UCAT secondary academies that enables consistent collaborative working that will lead to significant school improvement.

The impact of the work of SJP was highlighted in Ofsted reports including:

In UCAN's Section 8 Report in September 2014:

The Strategic School Improvement Partner is offering strong support and a clear agenda for improvement in promoting more effective quality assurance systems and in tackling underperformance in academy provision. The sponsor has strengthened its own team to support the academy in recognition that changes are required within a more urgent time frame.

In UCAN's Section 8 Report in March 2015:

Central to the instigation of a transformed culture of high aspiration and expectations has been the contribution of the Executive Principal. He has been the fulcrum for implementing rapid and profound changes. His wisdom, experience of outstanding practice and dynamic drive has ensured that the academy has moved forward rapidly.

In UAW's Section 5 Report in November 2015:

The Executive Principal, along with the new head of school are taking a strong lead on improving academy.

The head of school was one the SJP's team.

In UCEA's Section 5 report in April 2015:

The school's external partners (St John Plessington) are working extremely effectively together to raise standards and increase progress with increasing impact.

In UCEA's Section 8 Report in June 2015

The school has drawn very effectively on the support negotiated by the University of Chester Academy Trust from the St John Plessington Teaching School Alliance. The academy has benefited from this support in implementing new, more rigorous management processes.

In UAK's Section 5 Report in February 2015:

The multi - academy trust has now commissioned external support. The pace of improvement has begun to improve as a result.

The purpose of the System of Internal Control

The system of internal control is designed to manage risk to a reasonable level rather than to eliminate all risk of failure to achieve policies, aims and objectives; it can therefore only provide reasonable and not absolute assurance of effectiveness. The system of control is based on an ongoing process designed to identify and prioritise the risks to the achievement of Trust policies, aims and objectives, to evaluate the likelihood of those risks being realised and the impact should they be realised, and to manage them efficiently, effectively and economically. The system of internal control has been in place in the Academy Trust for the year ended 31 August 2015 and up to the date of approval of the annual report and financial statements.

Capacity to Handle Risk

The trustees have reviewed the key risks to which the Trust is exposed together with the operating, financial and compliance controls that have been implemented to mitigate those risks. The trustees are of the view that there is a formal ongoing process for identifying, evaluating and managing the Trust's significant risks that has been in place for the year ended 31 August 2015 and up to the date of approval of the annual report and financial statements. This process is regularly reviewed by the trustees.

The Risk and Control Framework

The Trust's system of internal financial control is based on a framework of regular management information and administrative procedures, including the segregation of duties and a system of delegation and accountability. In particular it includes:-

- comprehensive budgeting and monitoring systems with an annual budget and periodic financial reports which are reviewed and agreed by the trustees;
- regular reviews by the Board of Directors of reports which indicate financial performance against the forecasts and of major purchase plans, capital works and expenditure programmes;
- setting targets to measure financial and other performance;
- clearly defined purchasing (asset purchase or capital investment) guidelines;
- delegation of authority and segregation of duties; and
- identification and management of risks.

During the year Mclintocks continued to provide an internal audit service, they made two visits to each secondary academy and UCAT central and one visit to each primary academy. These visits considered income controls and general accounting systems, their reports were considered by the UCAT Audit and Scrutiny committee.

Review of Effectiveness

As Accounting Officer, the Managing Director has responsibility for reviewing the effectiveness of the system of internal control. During the year in question the review has been informed by:

- the work of the internal auditor;
- the work of the external auditor; and
- the work of the Senior Leadership Team within the Trust who have responsibility for the development and maintenance of the internal control framework.

The Accounting Officer has been advised of the implications of the result of their review of the system of internal control by the Audit and Scrutiny Committee and plans to address weaknesses and ensure continuous improvement of the system is in place.

NOTES TO THE FINANCIAL STATEMENTS

For the year ended 31 August 2015

ACCOUNTING POLICIES

Basis of Preparation

The financial statements are prepared under the historical cost convention in accordance with applicable UK Accounting Standards, the "Statement of Recommended Practice: Accounting and Reporting by Charities" ("SORP 2005"), the Academies Accounts Direction 2014 to 2015 issued by the EFA and the Companies Act 2006. The accounts include the Permanent Endowment funds received from Cheshire West and Chester Council.

A summary of the principal accounting policies, which have been applied consistently, except where noted, is set out below.

Going Concern

The trustees assess whether the use of the going concern basis is appropriate, i.e. whether there are any material uncertainties related to events or conditions that may cast significant doubt on the ability of the charitable company to continue as a going concern. The trustees make this assessment on a regular basis and at each year end.

At the balance sheet date the Trust had net assets of £42,929,000 after providing for long term commitments of £5,998,000 in respect of the non-teaching defined benefit scheme and £238,000 in respect of enhanced pensions due to former employees. The trust had net current assets of £3,176,000 at 31 August 2015.

The trustees have reviewed the fund balances at 31 August 2015 and cash flow forecasts for 2015/16 and future years, and consider it appropriate for the financial statements to be drawn up on the going concern basis.

Fund Accounting

Unrestricted funds represent those resources which may be used towards meeting any of the charitable objectives of the Academy Trust at the discretion of the trustees.

Restricted fixed asset funds are resources which are applied to specific capital purposes imposed by EFA/DfE and Sponsors where the asset acquired is held for a specific purpose.

Restricted general funds comprise of resources subject to specific restriction imposed by funders and include grants from EFA/DfE.

The capital of the Permanent Endowment funds received from CWAC must remain untouched, with the interest arising being used for the benefit of the students of the Academy.

Incoming resources

All incoming resources are recognised when the Academy Trust has entitlement to the funds, there is certainty of receipt and the amount can be measured with sufficient reliability.

NOTES TO THE FINANCIAL STATEMENTS

For the year ended 31 August 2015

Grants receivable

Grants are included in the Statement of Financial Activities on a receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the balance sheet. Where income is received in advance of entitlement its recognition is deferred and it is included in creditors as deferred income. Where entitlement occurs before income is received, the income is accrued. The general annual grant ('the GAG') from the DfE, which is intended to meet recurrent costs, is recognised on a receivable basis and is credited directly to the Statement of Financial Activities to the extent of the entitlement of the funds, any abatement in respect of the period is deducted from income and is recognised as a liability.

Capital grants are recognised on a receivable basis to the extent there is entitlement.

Other grants from government agencies and other bodies are recognised in the period in which they are receivable to the extent the conditions of funding have been met. Where income is received in advance of entitlement of receipt its recognition is deferred and included in creditors as deferred income. Where entitlement occurs before income is received the income is accrued.

Sponsorship income

Sponsorship income provided to the Academy Trust which amounts to a donation is recognised in the Statement of Financial Activities in the period in which it is receivable, where there is certainty of receipt.

Donations

Donations are recognised on a receivable basis where there is certainty of receipt and the amount can be readily measured.

Donated services and gifts in kind

The value of donated services and gifts in kind provided to the Academy Trust are recognised at their open market value in the period in which they are receivable as incoming resources, where the benefit to the Academy Trust can be reliably measured. An equivalent amount is included as expenditure under the relevant heading in the Statement of Financial Activities, except where the gift in kind was a fixed asset in which case the amount is included in the appropriate fixed asset category and depreciated over the useful economic life of the asset in accordance with the Academy Trust's policies.

Other income

Other income including hire of facilities is recognised in the period it is receivable and to the extent the goods have been provided or on completion of the service.

Interest receivable

Interest receivable is included in the Statement of Financial Activities on a receivable basis and is stated inclusive of related tax credits.

Resources expended

All expenditure is recognised in the period in which a liability is incurred and is classified under headings that aggregate all costs relating to that category. Where costs cannot be directly attributed to particular headings they have been allocated on a basis consistent with the use of resources, with central staff costs allocated on the basis of time spent, and depreciation charges allocated on the relevant proportions of the asset's use. Other support costs are allocated based on the spread of staff costs.

Cost of generating funds

These are costs incurred in attracting voluntary income, and those incurred in trading activities that raise funds.

NOTES TO THE FINANCIAL STATEMENTS

For the year ended 31 August 2015

Charitable activities

These are costs incurred on the Academy Trust's educational operations.

Governance costs

These include the costs attributable to the Academy Trust's compliance with constitutional and statutory requirements, including audit, strategic management and Governors' meetings and reimbursed expenses. All resources expended are stated inclusive of any irrecoverable VAT.

Tangible fixed assets

Assets costing £2,500 or more are capitalised as tangible fixed assets and are carried at cost, net of depreciation and any provision for impairment.

Where tangible fixed assets have been acquired with the aid of specific grants, either from the government or the private sector, they are included in the Balance Sheet at cost and are depreciated over their expected useful economic life. The related grants are credited to a restricted fixed asset fund in the Statement of Financial Activities and carried forward in the Balance Sheet. Depreciation on such assets is charged directly to the restricted fixed asset fund in the Statement of Financial Activities.

Depreciation is provided on all tangible fixed assets at rates calculated to write off the cost of each asset on a straight line basis over its expected useful life, as follows:

Long leasehold property 2% Fixtures, fittings and equipment 25% Computer equipment 25%

Assets in the course of construction are included at cost. Depreciation on these assets is not charged until they are brought into use.

A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying value of any fixed asset may not be recoverable. Shortfalls between the carrying value of fixed assets and their recoverable amounts are recognised as impairments. Impairment losses are recognised in the Statement of Financial Activities.

Donated assets

School buildings amounting to £2,500,000 for University Cathedral Free School have been purchased by the Education Funding Agency and donated to the Trust. The buildings have therefore been capitalised at market value based on the price paid by the EFA.

PFI agreement

University Academy Liverpool occupies buildings which are owned by Liverpool City Council and utilised by the Academy under a PFI agreement. The Academy pays revenue contributions in respect of the facilities management and building use. The contract will expire in the year 2031. The Academy does not have any rights or obligations of ownership in respect of these assets and therefore they are not included on the Academy's balance sheet. The revenue payment is recognised in the SOFA. Where the Academy procures and pays for additional furniture or equipment or changes to the building, the costs are capitalised and depreciated in accordance with the tangible fixed asset policy above.

Leased assets

Rentals under operating leases are charged to the Statement of Financial Activities on a straight line basis over the lease term.

NOTES TO THE FINANCIAL STATEMENTS

Leased school buildings

The Academy occupies leased school buildings over a fixed term, for a peppercorn rental, giving rights approximating to ownership. The buildings are therefore transferred to the Academy and capitalised at depreciated replacement value.

Taxation

The Academy Trust is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the Academy Trust is potentially exempt from taxation in respect of income or capital gains received (within categories covered by Chapter 3 Part 11 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992), to the extent that such income or gains are applied exclusively to charitable purposes.

Pension benefits

Retirement benefits to employees of the Academy Trust are provided by the Teachers' Pension Scheme ('TPS') and the Local Government Pension Scheme ('LGPS'). These are defined benefit schemes, are contracted out of the State Earnings-Related Pension Scheme ('SERPS') (until April 2016), and the assets are held separately from those of the Academy Trust.

The TPS is an unfunded scheme and contributions are calculated so as to spread the cost of pensions over employees' working lives with the Academy Trust in such a way that the pension cost is a substantially level percentage of current and future pensionable payroll. The contributions are determined by the Government Actuary on the basis of quadrennial valuations using a prospective benefit method. As stated in Note 19, the TPS is a multi-employer scheme and the Academy Trust is unable to identify its share of the underlying assets and liabilities of the scheme on a consistent and reasonable basis. The TPS is therefore treated as a defined contribution scheme and the contributions recognised as they are paid each year.

The LGPS is a funded scheme and the assets are held separately from those of the Academy Trust in separate trustee administered funds. Pension scheme assets are measured at fair value and liabilities are measured on an actuarial basis using the projected unit method and discounted at a rate equivalent to the current rate of return on a high quality corporate bond of equivalent term and currency to the liabilities. The actuarial valuations are obtained at least triennially and are updated at each balance sheet date. The amounts charged to operating surplus are the current service costs and gains and losses on settlements and curtailments. They are included as part of staff costs. Past service costs are recognised immediately in the Statement of Financial Activities if the benefits have vested. If the benefits have not vested immediately, the costs are recognised over the period until vesting occurs. The expected return on assets and the interest cost are shown as a net finance amount of other finance costs or credits adjacent to interest. Actuarial gains and losses are recognised immediately in other gains and losses.

Enhanced pensions

The cost of ongoing enhanced pensions to former members of staff are paid by the Academy annually and, as detailed in note 19, a provision is made at each balance sheet date for the actuarially estimated future cost of such pension enhancements. The movement in the provision arising from the annual reassessment is reflected in the Statement of Financial Activities.

Agency arrangements

The Academy Trust acts as an agent in the administering of 16-19 Bursary Funds from the EFA. Related payments received from the EFA and subsequent disbursements to students are excluded from the statement of financial activities to the extent that the Academy Trust does not have a beneficial interest in the individual transactions. The allowance of 5% as a contribution to administration costs is however recognised in statement of financial activities. Where funds have not been fully applied in the year then an amount will be included as amounts due to the EFA.

During the year ended 31 August 2015 seven (2014: twelve) of the above employees participated in the Teachers' Pension Scheme. During the period ended 31 August 2015, travel and subsistence expenses totalling £524 (2014: £nil) were reimbursed or paid directly to 2 trustees (2014:nil).

10 Trustees' and Officers' Insurance

The academy trust has opted into the Department of Education's risk protection arrangement (RPA), an alternative to insurance where UK government funds cover losses that arise. This scheme protects trustees and officers from claims arising from negligent acts, errors or omissions occurring whilst on academy business, and provides cover up to £10,000,000. It is not possible to quantify the trustees and officers indemnity element from the overall cost of the RPA scheme.

Other DfE Grants mainly relate to Pupil Premium funding and money received from the EfA to cover redundancy costs relating to pre Academy service costs.

The Trust's employees belong to two principal pension schemes: the Teachers' Pension Scheme England and Wales (TPS) for academic and related staff; and the Local Government Pension Scheme (LGPS) for non-teaching staff which is managed by Cheshire, Merseyside and Staffordshire Pension Funds. All are defined benefit schemes.

The pension costs are assessed in accordance with the advice of independent qualified actuaries. The latest actuarial valuation of the TPS was 31 March 2012 and of the LGPS 31 March 2013.

Contributions amounting to £261,636 (2014: £287,487) were payable to the schemes at 31 August 2015 and are included within creditors.

Ongoing commitment to enhanced pension payments to former academic staff:

As part of the staff restructuring, which took place at the University Church of England Academy in the 2010/11 Academic year, an ongoing commitment has been taken on by the Academy to fund annual enhanced pension payments to former academic staff. The enhanced pension payments will be paid to the former staff members for the remainder of their lives and the amount paid for the year ended 31 August 2015 was £10,077 (2014: £10,047).

The provision for future enhanced pension liabilities is reassessed at each balance sheet date and the movement required in the provision is reflected in the Statement of Financial Activities. The underlying assumptions used are 3,46% interest and 1.75% net interest. The provision required at 31 August 2015 has increased to £238,242, of which £10,077 is included in creditors due within a year on the Balance Sheet and the balance of £228,165 being included in the over 1 year Provision for future pensions.

Teachers' Pension Scheme

The Teachers' Pension Scheme (TPS) is a statutory, contributory, defined benefit scheme, governed by the Teachers' Pensions Regulations (2010) and, from 1 April 2014, by the Teachers' Pension Scheme Regulations 2014. Membership is automatic for full-time teachers in academies and, from 1 January 2007, automatic for teachers in part-time employment following appointment or a change of contract, although they are able to opt out.

The TPS is an unfunded scheme and members contribute on a 'pay as you go' basis – these contributions along with those made by employers are credited to the Exchequer. Retirement and other pension benefits are paid by public funds provided by Parliament.

Valuation of the Teachers' Pensions Scheme

Not less than every four years the Government Actuary, using normal actuarial principles, conducts a formal actuarial review of the TPS in accordance with the Public Service Pensions (Valuations and Employer Cost Cap) Directions 2014 published by HM Treasury. The aim of the review is to specify the level of future contributions. Actuarial scheme valuations are dependent on assumptions about the value of future costs, design of benefits and many other factors. The latest actuarial valuation of the TPS was carried out as at 31 March 2012 and in accordance with the Public Service Pensions (Valuations and Employer Cost Cap) Directions 2014. The valuation report was published by the Department for Education on 9 June 2014. The key elements of the valuation and subsequent consultation are:

- employer contribution rates set at 16.48% of pensionable pay (including a 0.08% employer administration charge (currently 14.1%)
- total scheme liabilities (pensions currently in payment and the estimated cost of future benefits) for service to the effective date of £191,500 million, and notional assets (estimated future contributions together with the notional investments held at the valuation date) of £176,600 million giving a notional past service deficit of £14,900 million
- an employer cost cap of 10.9% of pensionable pay will be applied to future valuations
- the assumed real rate of return is 3.0% in excess of prices and 2% in excess of earnings. The rate of real earnings growth is assumed to be 2.75%. The assumed nominal rate of return is 5.06%

During the year the employer contribution rate was 14.1%. The TPS valuation for 2012 determined an employer rate of 16.4% from September 2015, which will be payable during the implementation period until the next valuation as at March 2016, whereupon the employer contribution rate is expected to be reassessed and will be payable from 1 April 2019.

Employer and Employee contribution rates

From 1 April 2014 to 31 March 2015, the employee contribution rate ranged between 6.4% and 11.2%, depending on a members Full Time Equivalent salary and from March 2015 it ranged between 6.4% and 12.4%.

The pension cost paid to TPS in the year amounted to £1,330,974 (2014: £1,411,593).

A copy of the valuation report and supporting documentation is on the <u>Teachers' Pensions</u> website.

Under the definitions set out in Financial Reporting Standard (FRS 17) Retirement Benefits, the TPS is a multi-employer pension scheme. The Academy is unable to identify its share of the underlying assets and liabilities of the scheme.

Accordingly, the Academy has taken advantage of the exemption in FRS 17 and has accounted for its contributions to the scheme as if it were a defined-contribution scheme. The Academy Trust has set out above the information available on the scheme and the implications for the Academy Trust in terms of anticipated rates.

Local Government Pension Scheme

The Academies employ staff within three Local Government Pension Schemes (LGPS), those being Cheshire Pension Fund, Mersey Pension Fund and Staffordshire Pension Fund.

The LGPS is a funded defined-benefit scheme with the assets held in separate trustee administered funds. The total contributions made by the Trust for the period amounted to £1,026,000 of which employer's contributions totalled £779,000 and employees' contributions totalled £247,000. The agreed employer's contribution rates ranged from 10.5% to 23.3% with employee contributions varying from 5.5% to 9.9%. The last full actuarial valuation of the LGPS was as at March 2013 and the following information is based on an actuarial updated valuation based on the position as at 31 August 2015.

20 Related Party Transactions

Owing to the nature of the Trust's operations and the composition of the board of directors being drawn from local public and private sector organisations, it is inevitable that transactions will take place with organisations in which a member of the board of governors may have an interest.

All transactions involving such organisations, other than the University of Chester, are conducted at arm's length and in accordance with the Trust's financial regulations and normal procurement procedures. Transactions with the University are contracted at a cost basis and comply in all respects with the spirit and intent of the EFA's Academies Financial Handbook 2014 as it applies to transactions with parties connected to a Trust.

The following related party transactions took place in the year;

The Trust was the lead sponsor for the University Academy of Birkenhead until 17 March 2015; during the period the Trust received management fees for the provision of education and support services totalling £86,391 (2014: £188,410), the balance due at year-end was £nil (2014: £16,043).

The University of Chester, the sponsor and therefore a connected party, provided services costing £312,103 (2014: £383,128) during the year, these services were in the main for education specialists and staffing. The balance owed to the University of Chester at the year end was £169,042 (2014: £262,400). The Trust benefits from an extended credit facility of £250,000 with the University of Chester.

Included in the charge from the University was;

- The cost of office accommodation at Gateway House for UCFS totalling £50,000.
- Total donations relating to staff costs were £38,779, relating to two members of staff who work full time but are recharged at 20% (until 28 February 2015) and 90% respectively.
 The difference between the recharge and the actual cost is treated as a donation (note 1a).

Independent Reporting Accountant's Assurance Report on Regularity to University of Chester Academies Trust and the Education Funding Agency

In accordance with the terms of our engagement letter dated 4 September 2015 and further to the requirements of the Education Funding Agency (EFA) as included in the Academies: Accounts Direction 2014 to 2015, we have carried out an engagement to obtain limited assurance about whether the expenditure disbursed and income received by University of Chester Academies Trust during the period 1 September 2014 to 31 August 2015 have been applied to the purposes identified by Parliament and the financial transactions conform to the authorities which govern them.

This report is made solely to University of Chester Academies Trust and the EFA in accordance with the terms of our engagement letter. Our work has been undertaken so that we might state to the University of Chester Academies Trust and the EFA those matters we are required to state in a report and for no other purpose. To the fullest extent permitted by law, we do not accept or assume responsibility to anyone other than the University of Chester Academies Trust and the EFA, for our work, for this report, or for the conclusion we have formed.

Respective responsibilities of University of Chester Academies Trust's accounting officer and the reporting accountant

The accounting officer is responsible, under the requirements of University of Chester Academies Trust's funding agreement with the Secretary of State for Education dated 28 October 2014 and the Academies Financial Handbook extant from 1 September 2014, for ensuring that expenditure disbursed and income received is applied for the purposes intended by Parliament and the financial transactions conform to the authorities which govern them.

Our responsibilities for this engagement are established in the United Kingdom by our profession's ethical guidance and are to obtain limited assurance and report in accordance with our engagement letter and the requirements of the Academies: Accounts Direction 2014 to 2015. We report to you whether anything has come to our attention in carrying out our work which suggests that in all material respects, expenditure disbursed and income received during the period 1 September 2014 to 31 August 2015 have not been applied to purposes intended by Parliament or that the financial transactions do not conform to the authorities which govern them.

Approach

We conducted our engagement in accordance with the Academies: Accounts Direction 2014 to 2015 issued by the EFA. We performed a limited assurance engagement as defined in our engagement letter.

The objective of a limited assurance engagement is to perform such procedures as to obtain information and explanations in order to provide us with sufficient appropriate evidence to express a negative conclusion on regularity. A limited assurance engagement is more limited in scope than a reasonable assurance engagement and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in a reasonable assurance engagement. Accordingly, we do not express a positive opinion.

Our engagement includes examination, on a test basis, of evidence relevant to the regularity and propriety of the academy trust's income and expenditure.

INDEPENDENT AUDITOR'S REPORT ON REGULARITY

Our work included identification and assessment of the design and operational effectiveness of the controls, policies and procedures that have been implemented to ensure compliance with the framework of authorities including high level financial control areas and areas assessed of presenting a higher risk of impropriety. We undertook detailed testing, based on our assessment of risk of material irregularity, where such controls, policies and procedures apply to classes of transactions. This work was integrated with our audit on the financial statements to the extent evidence from the conduct of that audit supports the regularity conclusion.

Conclusion

In the course of our work, nothing has come to our attention which suggests that in all material respects the expenditure disbursed and income received during the period 1 September 2014 to 31 August 2015 has not been applied to purposes intended by Parliament and the financial transactions do not conform to the authorities which govern them.
