(e) Evidence of Book values as shown in first columns cannot be verified without detailed management information. Names and qualifications of authorities suggesting realisable values are not revealed for verification purposes. It seems that a fire-sale mentality has promoted the SOA realisable valuations. This is not the economic reality of a Duet asset. The assets are designed and maintained for longevity of service not as domestic pianos acquired cheaply through auction houses (as suggested) but as vehicles to attract annual rentals. Creditors best return on exposure is to allow the assets to be leased for a great deal more value than the fire-sale values suggested for auction. I point out that in almost all cases of musical instruments whether ancient string instruments or pianos, that auction house are the last resort and typically only market instruments which are either poorly maintained or subject to fire-sale environment, and that both private treatise sales and/or leasing is by far the most economically rewarding method of disposal.

The liabilities of the company do not show indebtedness to the shareholders and in particular ten years' worth of full salary for CEO (myself) as settled in the service agreement and 10 years of expenses incurred entirely for the benefit of the company. These liabilities should have been netted off against the assets.

It is unclear how the assets of two subsidiaries are being valued namely: Duet Adriatic (the motor yacht Chimera) and Sky Taste D.O.O. (the real estate known as Tom, Dick, and Harry). The business plans that persuaded the company to acquire those assets assume a return on investment greater than £8Million. If the business plan is not followed then substantial value of the shareholder/creditors will be lost.
