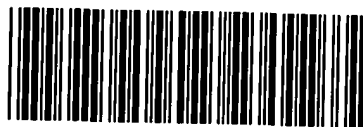

There were no political donations for the period (2022: £nil) and the Company did not incur any political expenditure (2022: £nil).

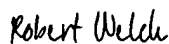
