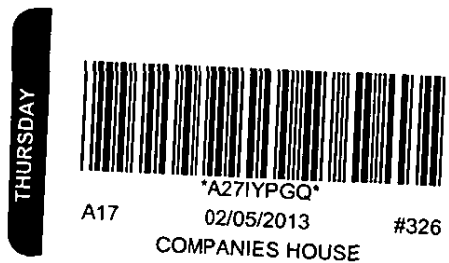

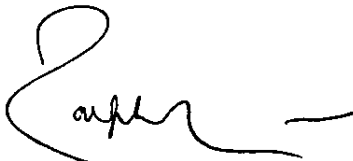
Audit Exemption Statement
